**INTRODUCTION OF BILLS**

The following bills were introduced:

**H. B. No. 465** - Representative Manning, G.

To amend section 4511.21 of the Revised Code to authorize the creation of school zones around specified preschools.

**H. B. No. 466** - Representative Sweeney.

To amend sections 111.42, 111.44, 149.43, 3501.05, 3503.011, 3503.09, 3503.10, 3503.12, 3503.13, 3503.14, 3503.15, 3503.16, 3503.18, 3503.19, 3503.20, 3503.21, 3503.24, 3503.26, 3503.28, 3503.30, 3503.33, 3505.18, 3505.181, 3505.183, 3509.03, 3509.05, 3511.02, 3511.09, 3599.11, 3599.18, 4506.07, 4507.06, and 4507.51; to enact new section 3503.11 and sections 3503.192 and 3503.22; and to repeal sections 3503.11, 3503.111, and 3503.29 of the Revised Code to create an automated voter registration system.

**H. B. No. 467** - Representative Scherer.

To amend sections 5733.41 and 5747.41 of the Revised Code to reduce the pass-through entity withholding tax rate to four per cent.

**H. B. No. 468** - Representative Lightbody.

Cosponsors: Representatives Boggs, Crawley, Crossman, Galonski, Leland, Miller, A., Russo.

To amend sections 4511.043 and 4511.204 of the Revised Code to alter the law governing the use of a handheld electronic wireless communications device while driving.

**H. B. No. 469** - Representatives Manchester, West.

To amend section 1751.12 and to enact section 3923.811 of the Revised Code to prohibit certain health insurance cost-sharing practices.

**H. B. No. 470** - Representative Rogers.

Cosponsors: Representatives Miranda, Boyd, Kelly, Crossman, Sobecki, Miller, A., West, Clites, Lepore-Hagan, Strahorn, Hicks-Hudson, Smith, K.

To amend sections 2305.111, 2901.13, and 2933.82 of the Revised Code to eliminate the period of limitations for the criminal prosecution of a person for rape and to extend the period of limitations for a civil action by a victim of childhood sexual abuse.

**H. B. No. 471** - Representative Rogers.

To amend section 2305.111 of the Revised Code to extend the period of limitations for a civil action by a victim of childhood sexual abuse.

**H. B. No. 472** - Representative Rogers.

To amend sections 2901.13 and 2933.82 of the Revised Code to eliminate the period of limitations for the criminal prosecution of a person for rape.

Said bills were considered the first time.
