Pursuant to House Rule No. 23, the Clerk called the House to order.

Representative Green was selected to preside under the Rule.

The journal of the previous legislative day was read and approved.

### INTRODUCTION OF BILLS

The following bills were introduced:

**H. B. No. 474** - Representative Hoops.

To enact section 5534.836 of the Revised Code to designate U.S. Route 224 in Putnam County as the "Putnam County Veterans Memorial Highway."

**H. B. No. 475** - Representatives Smith, K., Galonski.

Cosponsors: Representatives Boyd, Blair, Lepore-Hagan, Sobecki.

To amend sections 111.241, 3505.10, 3513.041, 3513.257, and 3513.31 and to enact section 3505.101 of the Revised Code to require a candidate for President or Vice-President of the United States to submit copies of the candidate's five most recent federal income tax returns for publication on the Secretary of State's official web site.

**H. B. No. 476** - Representatives Manning, D., Hambley.

Cosponsors: Representatives Becker, Ginter, Jones, Kick, Lang, Merrin, Stoltzfus, Cross, McClain, Wiggam, Scherer, Jordan.

To amend sections 163.021 and 163.041 and to enact section 163.022 of the Revised Code to amend the law regarding eminent domain and to declare an emergency.

**H. B. No. 477** - Representatives West, Kick.

Cosponsors: Representatives Lang, Lipps, Becker, Brent, Strahorn, Miranda, Smith, K., Seitz, Denson, Ingram, Dean, Russo, Miller, J., Butler, Hambley, Crossman.

To amend sections 120.08, 2705.031, 3123.54, 3123.55, 3123.56, 3123.57, 3123.58, 3123.63, 4503.233, 4507.20, and 4509.101 and to enact sections 3123.61 and 4510.023 of the Revised Code to alter the procedures and requirements governing the granting of limited driving privileges in certain criminal cases and cases involving failure to pay child support, to authorize a court in any proceeding to submit a report to the Registrar of Motor Vehicles regarding whether the defendant is competent to operate a motor vehicle, to

alter the reinstatement fees related to failure to provide proof of financial responsibility and vehicle immobilization, and to impose community service sanctions on persons who are the subject of child support order default determinations under specified circumstances.

Said bills were considered the first time.
