INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 478 - Representatives Miller, A., Miranda.

To amend sections 3310.02, 3310.03, 3310.032, and 3310.035; to enact section 3310.036; and to repeal section 3310.031 of the Revised Code to make changes regarding the eligibility criteria for the Educational Choice scholarship program.

H. B. No. 479 - Representatives Patterson, Perales.

Cosponsors: Representatives O'Brien, Miller, J., Rogers, Crossman.

To enact section 3781.60 of the Revised Code to require certain baseball stadiums to install protective netting.

H. B. No. 480 - Representatives Smith, T., Plummer.

Cosponsors: Representatives Riedel, Strahorn.

To amend Sections 265.10 and 265.210 of H.B. 166 of the 133rd General Assembly to make an appropriation to compensate school districts for property tax losses due to certain natural disasters.

Said bills were considered the first time.

Add the names: "Manning, D., Ginter, West"

In line 3 of the title, delete "blindness" and insert "disability"

In line 11, delete "blind" and insert "disability"; delete "section"

In line 12, delete "3304.28 of the Revised Code" and insert "the Americans with Disabilities Act of 1990, 42 U.S.C. 12102"

In line 17, delete "is blind" and insert "has a disability"

In line 28, delete "blindness" and insert "disability"

In line 30, delete "blindness-connected" and insert "disability-connected"

In line 34, delete "blind"; after "person" insert "with the disability"

The motion was agreed to and the bill so amended.
