INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 583 - Representatives Russo, Liston.

Cosponsors: Representatives Boyd, Clites, Lepore-Hagan, West.

To waive certain Medicaid requirements during the COVID-19 emergency declaration and to declare an emergency.

H. B. No. 584 - Representatives Crawley, Leland.

Cosponsors: Representatives Brent, Lightbody, Kelly, Miranda, Crossman, Miller, J., Liston, O'Brien, Russo, Lepore-Hagan, Boggs, Sobecki, Galonski, Weinstein, Smith, K.

To temporarily change eligibility and work search requirements under the Unemployment Compensation Law and to declare an emergency.

H. B. No. 585 - Representatives Patterson, Robinson.

Cosponsors: Representatives Miller, J., Ingram, Miranda, Lightbody, Galonski, Howse, West, Brent, Crossman, Boyd, Sobecki, Rogers, O'Brien, Weinstein, Smith, K.

To waive certain primary and secondary education requirements to account for school closings in compliance with the Director of Health's order due to the implications of COVID-19 and to declare an emergency.

H. B. No. 586 - Representatives Greenspan, Kelly.

To amend sections 125.035 and 125.607 of the Revised Code to require any state agency seeking to purchase supplies or services to comply with an applicable first or second procurement program and to prohibit any governmental ordering office from combining multiple parts of a larger related project to avoid using the procurement list maintained by community rehabilitation programs.

H. B. No. 587 - Representatives Robinson, Patterson.

Denson, Liston, Crossman, Clites, Boyd.

To amend sections 3310.02, 3310.03, 3310.032, 3310.08, and 3310.16 of the Revised Code to suspend all performance-based Educational Choice scholarships for the 2020-2021 school year, to make changes to the Educational Choice Scholarship Program and the expansion of that program for the 2021-2022 school year and each school year thereafter, and to declare an emergency.

H. B. No. 588 - Representatives Russo, Sobecki.

Cosponsors: Representatives Miranda, Miller, J., Galonski, Brent, Rogers, Weinstein, Skindell, Smith, K., Brown, Patterson, Lightbody, Blair, O'Brien, Lepore-Hagan, Howse, Crossman, Boyd, Clites, Liston, Upchurch, West.

To delay eligibility redeterminations for certain public assistance programs, temporarily modify income eligibility requirements for certain public assistance programs, and to declare an emergency.

H. B. No. 589 - Representatives Crossman, Rogers.

To require insurers offering business interruption insurance to cover losses attributable to viruses and pandemics and to declare an emergency.

H. B. No. 590 - Representatives Crossman, Rogers.

To amend section 1345.99 and to enact section 1345.033 of the Revised Code to prohibit price gouging after a declaration of an emergency and to declare an emergency.

Said bills were considered the first time.
