INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 683 - Representative Perales.

To amend sections 3301.0711, 3301.0714, and 3317.03 and to enact sections 3310.31 and 3310.311 of the Revised Code and to amend Sections 265.10 and 265.210 of H.B. 166 of the 133rd General Assembly, as subsequently amended, to establish scholarships for children of full-time United States military service members to attend chartered nonpublic schools and to make an appropriation.

To waive state testing requirements for the 2020-2021 school year, to provide exemptions from state report cards and other provisions related to test results, and to declare an emergency.
