The House met pursuant to adjournment.

Pursuant to House Rule No. 23, the Clerk called the House to order.

Representative Stein was selected to preside under the Rule.

The journal of the previous legislative day was read and approved.

INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 691 - Representatives Manchester, Plummer.

To amend sections 3901.38, 3901.381, 3901.383, 3901.3811, 3901.3812, and 3901.3814 and to enact section 5167.104 of the Revised Code to amend the prompt pay requirements for providers and third-party payers and to include Medicaid managed care organizations.

H. B. No. 692 - Representative Swearingen.

Cosponsors: Representatives Lipps, LaRe, Lanese, Carruthers, Roemer, Seitz, Richardson, Stoltzfus, Sweeney, Upchurch, Cross, Scherer, Stein.

To amend sections 317.32, 1337.11, 1337.12, 1337.22, 1337.25, 2107.01, 2107.03, 2107.07, 2107.17, 2107.18, 2107.24, 2107.27, 2107.29, 2107.30, 2107.31, 2107.33, 2107.60, 2107.63, 2129.05, 2133.01, 2133.02, 5302.22, 5817.01, and 5817.05 and to enact sections 1337.121 and 2107.031 of the Revised Code to expand the laws on wills, declarations or living wills, durable powers of attorney for health care, and transfer on death designation affidavits by providing for their execution electronically.

H. B. No. 693 - Representatives Swearingen, Manning, G.

Cosponsors: Representatives Patton, Riedel.

To prohibit, for the 2020-2021 school year only, public and chartered nonpublic schools from opening for instruction prior to the Wednesday after Labor Day and to declare an emergency.

H. B. No. 694 - Representatives Perales, Smith, T.

Cosponsors: Representatives Riedel, Butler, Plummer, Strahorn.

To enact section 113.42 of the Revised Code to establish the Permanent Replacement Housing Program and to make an appropriation.

H. B. No. 695 - Representatives Becker, Romanchuk.

Cosponsors: Representatives Butler, Dean, Vitale, Keller.

To amend sections 101.27, 141.04, and 4928.64 of the Revised Code to enact the "Average Wage Fully Uniform Law (AWFUL)" to set the baseline compensation for General Assembly members equal to Ohio's median household income.

Said bills were considered the first time.

BILLS FOR THIRD CONSIDERATION

Sub. H. B. No. 425-Representative Wiggam.

Cosponsors: Representatives Kick, Antani, Lang, Merrin, Becker, Riedel, Vitale, Manchester, Powell, Koehler, Scherer, Romanchuk.

To amend sections 2923.12, 2923.126, 2923.128, and 2923.16 of the Revised Code to modify the requirement that a concealed handgun licensee must notify a law enforcement officer that the licensee is authorized to carry a concealed handgun and is carrying a concealed handgun when stopped, was taken up for consideration the third time.

The question being, "Shall the bill pass?"

Representative Callender moved that **Sub. H. B. No. 425**-Representative Wiggam, be informally passed and that it be taken up for consideration on: Thursday, June 11, 2020.

The motion was agreed to without objection.

On motion of Representative Callender, the House adjourned until Tuesday, June 9, 2020 at 9:00 o'clock a.m.
