INTRODUCTION OF BILLS

The following bill was introduced:

H. B. No. 798 - Representative Hoops.

To amend sections 3706.46, 3706.49, 3706.55, 3706.61, 4928.143, and 4928.471 and to enact sections 3706.491, 3706.551, 4906.105, 4928.149, 4928.473, 5301.075, 5301.076, 5301.077, 5311.195, 5311.196, and 5311.197 of the Revised Code to delay for one year the charges and payments for nuclear resource and renewable energy credits, and revise certain other laws, enacted by H.B. 6 of the 133rd General Assembly, to amend Power Siting Board law and other electric utility law, to prohibit certain restrictions on solar energy systems, and to declare an emergency.
