INTRODUCTION AND FIRST CONSIDERATION OF BILLS

The following bills were introduced and considered for the first time:

S. B. No. 96 - Senators Dolan, Yuko

Cosponsors: Senators Eklund, Thomas

To amend section 1901.181 of the Revised Code to grant the Cleveland Housing Court jurisdiction in any review or appeal of a final order of an administrative body that relates to a local building, health, or safety code.

S. B. No. 97 - Senator Huffman, S.

Cosponsor: Senator Huffman, M.

To enact sections 3726.01, 3726.02, 3726.03, 3726.04, and 3726.05 and to repeal section 5162.80 of the Revised Code regarding the provision of cost estimates for scheduled health care services and health care services requiring insurer preauthorization.

S. B. No. 98 - Senator Maharath

To amend section 121.30 and to enact sections 121.34 and 121.341 of the Revised Code to create the Ohio Asian-American and Pacific Islander Affairs Commission and the Office of Asian-American and Pacific Islander Affairs and to make an appropriation.

S. B. No. 99 - Senator Thomas

Cosponsors: Senators Sykes, Antonio, Fedor, Craig

To amend sections 109.57, 2151.23, 2152.02, 2152.021, 2152.10, 2152.12, 2152.13, 2152.14, 2152.26, and 2505.02 and to repeal section 2152.121 of the Revised Code to eliminate mandatory bindovers and reverse bindovers, and modify the law governing a discretionary bindover, of an alleged juvenile offender from a juvenile court to a criminal court.
