## REPORTS OF REFERENCE AND BILLS FOR SECOND CONSIDERATION

To amend sections 924.01, 3719.01, and 3719.41, to enact sections 924.212, 928.01, 928.02, 928.03, 928.04, 928.05, 928.06, 928.07, and 928.99 of the Revised Code, and to amend the versions of sections 3719.01 and 3719.41 of the Revised Code that are scheduled to take effect on March 22, 2020, to decriminalize hemp and hemp products, to establish a hemp cultivation and processing licensing program, and to establish a hemp marketing program, was considered the third time.

### OFFERING OF RESOLUTIONS

Senator Kunze offered the following resolution:

S. R. No. 95-Senator Kunze

To urge Congress to maintain federal funding for Special Olympics.

WHEREAS, For more than fifty years, Special Olympics has helped foster the acceptance and inclusion of individuals with intellectual disabilities through training, competition, education, health screenings, and community events; and

WHEREAS, The mission of Special Olympics is to provide year-round sports training and athletic competition in a variety of sports for children and adults with intellectual disabilities, giving them opportunities to develop physical fitness, demonstrate courage, experience joy, and participate in sharing gifts, skills, and friendship with their families, other athletes, and the community; and

WHEREAS, Special Olympics involves more than 4.4 million athletes in 170 countries, including more than 900,000 in North America; and

WHEREAS, Special Olympics Ohio has approximately 200 community partners and serves more than 27,000 athletes; and

WHEREAS, Students with and without intellectual disabilities are also playing and competing together, on the same team, through Special Olympics Unified Sports; and

WHEREAS, Special Olympics offers health events where athletes receive free health screenings and health education, and where health professionals are trained to offer year-round health access to people with intellectual disabilities in their communities; and

WHEREAS, Special Olympics has provided over 58,000 health screenings and trained over 10,000 health care professionals in the United States. Globally, Special Olympics has provided over 1.9 million health screenings in over 130 countries and trained over 220,000 health care professionals; and

WHEREAS, Federal funding represents approximately 10% of the organization's budget; now therefore be it

RESOLVED, That we, the members of the 133rd General Assembly of the State of Ohio, urge Congress to maintain federal funding for Special Olympics; and be it further

RESOLVED, That the Clerk of the Senate transmit duly authenticated

copies of this resolution to the Speaker and Minority Leader of the United States House of Representatives, to the Majority Leader and Minority Leader of the United States Senate, to Ohio's congressional delegation, and to the news media of Ohio.
