**REPORTS OF REFERENCE AND BILLS FOR SECOND  
CONSIDERATION**

Senator Obhof reports for the standing committee on Rules and Reference, recommending that the following bills and resolution, standing in order for second consideration, be referred to committee as recommended:

**Sub. H. B. No. 236** -Representatives Smith, T., Plummer, et al.

To amend sections 2903.11, 2903.12, and 2903.13 of the Revised Code to increase penalties for certain assault offenses if the victim is a hospital police officer.

To the Committee on Judiciary.

**S. R. No. 376** -Senator Obhof, et al.

To urge the United States Congress to ratify the United States-Mexico-Canada Agreement.

To the Committee on Transportation, Commerce and Workforce.

**S. B. No. 187** -Senator Schaffer

To amend section 2919.22 of the Revised Code to prohibit a sexually suggestive performance by a minor and, if the offender is a D liquor permit holder, to require the court to order the revocation of the permit.

To the Committee on General Government and Agency Review.

**S. B. No. 190** -Senator Schaffer

To amend sections 5747.02, 5747.08, and 5747.98 and to enact section 5747.64 of the Revised Code to allow an income tax credit for law enforcement officials who purchase safety or protective items to be used in the course of official law enforcement activities.

To the Committee on Ways and Means.

**S. B. No. 196** -Senator Eklund, et al.

To amend sections 2151.421, 2317.02, and 2921.22 of the Revised Code to provide generally a testimonial privilege for communications between a qualified advocate rendering advocacy services and a victim of domestic violence, human trafficking, menacing by stalking, or sexual violence, to exempt the nondisclosure of that privileged communication from the offense of failure to report a crime, to require a qualified advocate to report knowledge or reasonable suspicion of child abuse or neglect of the victim except for privileged communications, and to specify circumstances in which the victim is considered to have waived the privilege.

**S. B. No. 198** -Senators Huffman, S., Antonio, et al.

To enact sections 3902.50, 3902.51, 3902.511, 3902.52, 3902.53, 3902.531, 3902.54, and 3902.55 of the Revised Code regarding out-of-network care.

To the Committee on Insurance and Financial Institutions.

**S. B. No. 201** -Senator Dolan

To amend sections 4121.12, 4121.121, 4123.01, 4123.26, 4123.291, 4123.32, 4123.341, 4123.35, 4141.24, 4740.131, 5733.40, 5747.07, and 5751.01 and to enact sections 4133.01, 4133.02, 4133.03, 4133.04, 4133.05, 4133.06, 4133.07, 4133.08, 4133.09, 4133.10, 4133.11, 4133.12, 4133.13, 4133.14, and 4133.99 of the Revised Code to create alternate employer organizations.

To the Committee on Transportation, Commerce and Workforce.

**S. B. No. 202** -Senators Thomas, Craig, et al.

To repeal section 9.68 of the Revised Code and to repeal on December 28, 2019, the version of section 9.68 of the Revised Code that is scheduled to take effect on that date, to restore local authority to generally regulate firearms-related conduct.

To the Committee on General Government and Agency Review.

**S. B. No. 203** -Senators Thomas, Lehner, et al.

To amend sections 2929.28 and 5122.311 and to enact section 2923.27 of the Revised Code to regulate the transfer of firearms at a gun show.

To the Committee on Government Oversight and Reform.

To amend Section 285.10 of H.B. 529 of the 132nd General Assembly to modify the purpose of a capital appropriation.
