**INTRODUCTION AND FIRST CONSIDERATION OF BILLS**

The following bills were introduced and considered for the first time:

**S. B. No. 236** - Senator Huffman, S.

Cosponsors: Senators Schaffer, Hackett.

To amend sections 3748.04, 4773.01, and 4773.061 and to enact section 4773.10 of the Revised Code regarding the Ohio Department of Health's Radiation Control Program and the regulation of radiation technology professionals.

**S. B. No. 237** - Senator Johnson.

Cosponsors: Senators McColley, Brenner, Hoagland, Obhof, Schaffer, Rulli, Roegner.

To amend sections 2307.601, 2901.05, and 2901.09 and to enact sections 2901.091 and 2901.092 of the Revised Code to enact the Ohio Duty to Retreat Act to modify the law regarding self-defense.

**OFFERING OF RESOLUTIONS**
