INTRODUCTION AND FIRST CONSIDERATION OF BILLS

The following bills were introduced and considered for the first time:

S. B. No. 250 - Senator Williams.

To enact section 4731.92 of the Revised Code regarding the authority of a physician to operate certain radiation-generating equipment.

S. B. No. 251 - Senator Lehner.

To amend section 5104.042 and to enact section 5104.0113 of the Revised Code to require child care providers to complete an annual infant safe sleep education program established by the Department of Job and Family Services and to make an appropriation.

S. B. No. 252 - Senators Hackett, Craig.

Cosponsors: Senators Brenner, Kunze, Lehner, Thomas, Williams, Yuko.

To enact sections 3902.50 and 3902.51 of the Revised Code to prohibit "fail first" coverage of drugs used to treat stage four advanced metastatic cancer.
