To the Committee on Agriculture and Natural Resources.

Sub. H. B. No. 163 -Representative Brinkman, et al.

To amend sections 5747.50, 5747.51, and 5747.53 and to enact sections 9.662, 743.80, and 5747.504 of the Revised Code to create a process for withholding local government funds and state water and sewer assistance from municipal corporations that engage in certain water and sewer practices with respect to extraterritorial service.

To the Committee on Energy and Public Utilities.

H. B. No. 450 -Representative Stephens, et al.

To amend sections 319.27, 321.06, 503.28, and 3313.28 and to enact section 117.171 of the Revised Code to require fiscal officers of certain

RESOLUTIONS REPORTED BY COMMITTEE

S. C. R. No. 10-Senator Lehner.

To approve the Director of Health's proposed revision of Chapter 3701-36 of the Ohio Administrative Code establishing standards to be met by boards of health and local health departments and procedures for payment of state subsidies for meeting those requirements.

WHEREAS, Ohio law requires the Director of Health to adopt rules establishing both minimum standards and optimum achievable standards for boards of health and local health departments and a formula for distributing state subsidy funds according to the level at which those standards are met; and

WHEREAS, The rules have been adopted as required by section 3701.342 of the Revised Code and are included in Chapter 3701-36 of the Administrative Code; and

WHEREAS, The Director of Health issued a notice of public hearing for August 1, 2018, to hear comments regarding its proposal to revise Chapter 3701-36 of the Administrative Code by amending rules 3701-36-01, 3701-36-02, 3701-36-03, 3701-36-05, 3701-36-11, and 3701-36-14, rescinding and proposing new rules 3701-36-10 and 3701-36-12, and rescinding rules 3701-36-04 and 3701-36-13; and

WHEREAS, The Director of Health's proposed revision of Chapter 3701-36 of the Administrative Code includes standards for protecting people from disease and injury, monitoring health status, assuring a safe and healthy environment, promoting healthy lifestyles, and addressing the need for

personal health services, as well as procedures for payment of state subsidies for meeting those standards; and

WHEREAS, On August 1, 2018, the Department of Health conducted a public hearing on its proposed revision of Chapter 3701-36 of the Administrative Code, and on August 13, 2018, the Joint Committee on Agency Rule Review considered the proposed revision of Chapter 3701-36 and took no action against it; and

WHEREAS, Section 3701.342 of the Revised Code provides that rules adopted by the Director of Health pursuant to that section cannot take effect unless approved by concurrent resolution of the General Assembly; now therefore be it

RESOLVED, That we, the members of the 133rd General Assembly of the State of Ohio, in adopting this concurrent resolution, approve the Director of Health's proposed revision of Chapter 3701-36 of the Administrative Code, as considered in a public hearing on August 1, 2018, and by the Joint Committee on Agency Rule Review on August 13, 2018; and be it further

RESOLVED, That the Clerk of the Senate transmit duly authenticated copies of this resolution to the Director of Health, the Director of the Joint Committee on Agency Rule Review, and the Director of the Legislative Service Commission.
