S. B. No. 364 - Senator Roegner.

To enact sections 4731.11 and 4731.111 of the Revised Code to enter into the Interstate Medical Licensure Compact.

**S. B. No. 365 -** Senator Fedor. Cosponsors: Senators Maharath, Gavarone, Craig, Thomas, Yuko, Antonio.

To amend Section 12 of H.B. 197 of the 133rd General Assembly to extend the authorization for members of a public body to hold and attend meetings or hearings via electronic technology, during the period of the emergency declared by Executive Order 2020-01D on March 9, 2020, until the declared emergency is terminated.

**S. B. No. 366 -** Senator Williams. Cosponsors: Senators Antonio, Yuko, Craig, Thomas. To enact section 2903.17 of the Revised Code to prohibit assault by a law enforcement officer.

S. B. No. 367 - Senator Brenner.

To prohibit state institutions of higher education from requiring any student to reside in on-campus housing for the 2020-2021 school year and to declare an emergency.

S. B. No. 368 - Senator Brenner.

To amend section 3301.07 of the Revised Code to require the use of phonics as the primary technique for teaching reading and writing in grades kindergarten through five and to make an appropriation.
