**REPORTS OF REFERENCE AND BILLS FOR SECOND
CONSIDERATION**

Senator Carnes reports for the Standing Committee on Reference, recommending that the following bills, standing in order for second consideration, be referred to committee as recommended:

S. B. No. 86-Senators Stivers, Miller, Goodman, Jacobson, Randy Gardner, Coughlin, Amstutz, Brady, Herington, Fedor.

To amend sections 2305.234, 3701.071, 4715.42, and 4731.295 of the Revised Code to extend immunity from liability for services provided by volunteer health care professionals and workers to more health care facilities and to nonprofit referring organizations, to increase the maximum allowable income of individuals who may be served by volunteers having immunity from liability, and to amend the version of section 2305.234 of the Revised Code that is scheduled to take effect January 1, 2004, to continue the provisions of this act on and after that effective date.

To the Committee on Health, Human Services and Aging.

S. B. No. 87-Senators Dann, Miller, Coughlin, Brady.

To amend section 149.43 of the Revised Code to require that a public office or person responsible for public records provide copies of public records within ten days or, if the copies are provided by United States mail, within fifteen days, after receiving the request and to amend the version of section 149.43 of the Revised Code that is scheduled to take effect January 1, 2004, to continue the provisions of this act on and after that effective date.

BILLS FOR THIRD CONSIDERATION

Sub. S. B. No. 64-Senators Goodman, Randy Gardner, Stivers, Jacobson.

To amend sections 1337.091, 1339.411, 1339.412, 1339.66, and 2109.62 and to enact section 1339.621 of the Revised Code to provide for distribution of the trust estate upon a probate court's termination of small trusts and representation in a trust, to specify the circumstances for the revocation or nonrevocation of a power of attorney upon the termination of the marriage between the principal and the principal's spouse as attorney in fact or upon their entering into a separation agreement, to specify when the forfeiture or postponement provisions of a spendthrift provision in an inter vivos or testamentary trust apply to a property interest that qualifies as a qualified terminable interest property deduction, and to specify when such a trust may require or permit the accumulation for more than one year of any income of property that qualifies as such an interest, was considered the third time.

The question being, "Shall the bill, **Sub. S. B. No. 64**, pass?"
