Synopsis of House Committee Amendments*

Amendments adopted by the House committee add or alter three provisions of the bill. The amendments require the construction of a Holocaust memorial on the grounds of Capitol Square, make changes to capital appropriations items in the Administrative Building Fund administered by the Adjutant General, and make changes to capital appropriations items in the Higher Education Improvement Fund administered by the Board of Regents. The amendments specifically alter the bill as follows:

Holocaust memorial on capitol grounds

Provides for the design and erection on the Capitol Square grounds of a memorial to victims of the Holocaust and to the Ohioans who participated in the liberation of the death camps during World War II.

Requires the Ohio Arts Council and the Board to work together to invite, accept, and evaluate proposals for the memorial, and to jointly select from among the proposals the memorial to be designed and erected.

Specifies that only preliminary construction activities are to be paid for with public funds, and that planning for and the design and erection of the memorial are to be paid for with only private contributions.

Authorizes the Capitol Square Foundation to accept private contributions for the Holocaust memorial and requires them to be deposited into the Capitol Square Holocaust Memorial Fund.

Adjutant General capital appropriations

Makes the following changes to Administrative Building Fund (Fund 7026) capital appropriation items under the Adjutant General:

Eliminates item C74536, Emergency Renovations, with an appropriation of \$1,532,023;

Reestablishes item C74502, Roof Replacement - Various Facilities, with an appropriation of \$1,532,023, and reallocates \$1,085,363 to that item;

Reallocates \$4,400 from item C74503, Electrical Systems - Various Facilities; \$40,102 from item C74504, Camp Perry Facility/Infrastructure Improvements; \$87,764 from item C74505, Replace Windows and Doors - Various Facilities; \$430,377 from item C74506, Plumbing Renovations - Various Facilities; \$20,292 from item C74507, Paving Renovations - Various Facilities; \$293,518 from item C74508, HVAC Systems - Various Facilities; \$106,390 from item C74510, Masonry Renovations; \$102,520 from item C74528, Camp Perry Improvements.

Board of Regents capital appropriations

Makes the following changes to Higher Education Improvement Fund (Fund 7034) capital appropriation items:

Reestablishes C23525, CWRU Mt. Sinai Skills and Simulation Center, with an appropriation of \$500,000;

Reestablishes C23535, CWRU Energy Center, with an appropriation of \$333,333;

Decreases the appropriation for item C23529, Non-credit Job Training Facilities, under Board of Regents, by \$1,366,820, and reallocates \$866,811 to that item;

Reallocates \$95,695 from item C23524, Supplemental Renovations Library Depositories, under Board of Regents;

Reallocates \$1,875 from item C26051, Cleveland Speech and Hearing Center, under Cleveland State University;

Reallocates \$15,000 from item C27531, Glenn Helen Eco Art Classroom; and \$232,918 from item C27544, Advanced Laser Manufacturing, under Wright State University;

Reallocates \$38,676 from item C37805, Non-credit Job Training; and \$239 from item C37830, CCC Auto Lab Improvements, under Cuyahoga Community College;

Reallocates \$16,695 from item C39010, Roadway Improvement, under Edison State Community College;

Reallocates \$3,873 from item C36403, Nursing Online; \$7,619 from item C36406, ITB Renovation; and \$21,348 from item C36407, Nursing Skilled Trade Center, under Terra State Community College;

Reallocates \$3,768 from item C36303, College Hall Rehabilitation, under Hocking Technical College;

Reallocates \$5,000 from item C38101, Building Renovations; \$79,933 from item C38102, Training and Education Facility; and \$99,160 from item C38103, Instructional and Data Processing Equipment, under James Rhodes State Community College;

Reallocates \$245,012 from item C36207, College and Health Science Hall - ESI Phase 2, under Zane State College.
