Section 1. All items in this section are hereby appropriated 6
out of any moneys in the state treasury to the credit of the 7
designated fund. For all appropriations made in this section, 8
those in the first column are for fiscal year 2014, and those in 9
the second column are for fiscal year 2015. 10

If any provision of law contained in this act, or if any application of any provision of law contained in this act, is held invalid, the invalidity does not affect other provisions of law contained in this act and their applications that can be given effect without the invalid provision or application. 30

Section 4. The sections of law contained in this act, and the items of law of which the sections of law contained in this act are composed, are not subject to the referendum under Ohio Constitution, Article II, Section 1d and section 1.471 of the Revised Code and therefore go into immediate effect when this act becomes law. 37

Section 5. An item that composes the whole or part of a section of law contained in this act has no effect after June 30, 2015, unless the context clearly indicates otherwise. 43
