## A BILL

To amend sections 1545.05 and 1545.06 of the	1
Revised Code to require boards of county	2
commissioners to appoint additional park board	3
commissioners and allow for public comment	4
during appointment process.	5

## BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

Section 1. That sections 1545.05 and 1545.06 of the	6
Revised Code be amended to read as follows:	7
Sec. 1545.05. (A) Upon the creation of a park district,	8
the probate judge shall appoint three <u>members to the board of</u>	9
park commissioners who shall take office immediately and whose	10
terms shall expire one, two, and three years, respectively, from	11
the first day of January next after the date of their	12
appointment. Thereafter, their successors shall be appointed by	13
the probate judge for terms of three years. Before entering upon	14
the performance of the duties of the office, each <del>commissioner</del>	15
member of the board of park commissioners shall take an oath to	16
perform faithfully the duties of the office and shall give bond	17
for that faithful performance in the sum of five thousand	18

dollars. The bond shall be approved by and filed with the county19auditor. The members of the board of park commissioners shall20serve without compensation, but shall be allowed their actual21and necessary expenses incurred in the performance of their22duties.23

(B) Any board of park commissioners of a park district may 24 elect to expand the membership of the board from three members 25 to five members upon a majority vote of the board. Upon such a 26 vote, the board shall certify to the probate judge board of 27 county commissioners of the county in which the park district is 28 29 <u>located</u> a resolution requesting the <del>judge to board of county</del> commissioners appoint two additional members to the board. The 30 probate judge board of county commissioners shall appoint those 31 additional members, and they shall take office immediately upon 32 their appointment. One member shall be appointed to a term that 33 expires on the first day of January of the year following the 34 year of that member's appointment, and one member shall be 35 appointed to a term that expires on the first day of January of 36 the second year following the year of that member's appointment. 37 Thereafter, their successors shall be appointed by the probate 38 judge board of county commissioners for terms of three years. 39

(C) For appointments made under division (B) of this40section, a member of the appointing board of county41commissioners is ineligible for appointment as a member of the42board of park commissioners.43

(D) Before an appointing probate judge or board of county44commissioners makes an appointment under this section or section451545.06 of the Revised Code, the judge or board shall provide an46opportunity for public comment on that appointment.47
