# BE IT RESOLVED BY THE HOUSE OF THE STATE OF OHIO (THE SENATE CONCURRING):

WHEREAS, When the General Assembly adopts a joint	12
resolution proposing an amendment to the Ohio Constitution	13
under Ohio Constitution, Article XVI, Section 1, it may	14
designate, under section 3505.063 of the Revised Code, a group	15
of members who voted in support of the joint resolution to	16
prepare arguments for the proposed amendment and, unless no	
members voted in opposition, a group of members who voted in	
opposition to the joint resolution to prepare arguments against	
the proposed amendment; and	
WHEREAS, The General Assembly, if in session, is required	21
WHEREIG, THE GENETAL RESEMBLY, II IN SESSION, IS required	21
to name the person or persons who will prepare the argument,	22
explanation, or both, for any law, section, or item submitted	23

to the electors by referendum petition, under Ohio
Constitution, Article II, Section 1g; now therefore be it

RESOLVED, That, when the 130th and 131st General Assemblies adopt a joint resolution proposing an amendment to the Ohio Constitution, the President of the Senate and the Speaker of the House of Representatives, on behalf of the 131st General Assembly, may designate a group of members who voted in support of the joint resolution to prepare arguments for the proposed amendment and, unless no members voted in opposition, a group of members who voted in opposition to the joint resolution to prepare arguments against the proposed amendment; and be it further

RESOLVED, That the President of the Senate and the Speaker of the House of Representatives, on behalf of the 131st General Assembly, may designate the person or persons who will prepare the argument, explanation, or both, for any law, section, or item submitted to the electors by referendum petition during the 131st General Assembly; and be it further

RESOLVED, That the President of the Senate and the Speaker of the House of Representatives, on behalf of the 131st General Assembly, may designate the person or persons who will prepare the argument against any constitutional amendment proposed by initiative petition during the 131st General Assembly; and be it further

RESOLVED, That the President of the Senate and the Speaker of the House of Representatives make their designations so as to leave the designated group or groups of members, person, or persons with sufficient time to prepare and file their arguments with the Secretary of State not later than the eightieth day before the day of the election at which the issue will be submitted to the electors.
