WHEREAS, More than 122,000 men, women, and children in the	4
United States, including approximately 3,200 Ohioans, are	5
currently awaiting life-saving organ transplant. Of these, 22	6
perish each day while waiting for compatible organs to become	7
available; and	8
WHEREAS, A single person can potentially save the lives of	9
eight people by donating such major organs as the heart, lungs,	10
liver, pancreas, kidneys, and small intestine and improve the	11
lives of more than 50 others through donations of tissues,	12
corneas, veins, skin, and other tissue. Indeed, in 2015, 353	13
Ohioans have shared the gift of life through organ donation,	14
enabling 1,084 individuals to have a second chance at a healthy	15

WHEREAS, More than 5.3 million Ohioans have made the	17
