То	amend section 3313.671 of the Revised Code to	1
	require pupils to be immunized against	2
	meningococcal disease at an age recommended by	3
	the Department of Health.	4

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

Section 1. That section 3313.671 of the Revised Code be	5
amended to read as follows:	6
Sec. 3313.671. (A)(1) Except as otherwise provided in	7
division (B) of this section, no pupil, at the time of initial	8
entry or at the beginning of each school year, to an elementary	9
or high school for which the state board of education prescribes	10
minimum standards pursuant to division (D) of section 3301.07 of	11
the Revised Code, shall be permitted to remain in school for	12
more than fourteen days unless the pupil presents written	13
evidence satisfactory to the person in charge of admission, that	14

the pupil has been immunized by a method of immunization	15
approved by the department of health pursuant to section 3701.13	16
of the Revised Code against mumps, poliomyelitis, diphtheria,	17
pertussis, tetanus, rubeola, and rubella or is in the process of	18
being immunized.	19
(2) Except as provided in division (B) of this section, no	20
pupil who begins kindergarten at an elementary school subject to	21
the state board of education's minimum standards shall be	22
permitted to remain in school for more than fourteen days unless	23
the pupil presents written evidence satisfactory to the person	24
in charge of admission that the pupil has been immunized by a	25
department of health-approved method of immunization or is in	26
the process of being immunized against both of the following:	27
(a) During or after the school year beginning in 1999,	28
hepatitis B;	29
(b) During or after the school year beginning in 2006,	30
chicken pox.	31
(3) Except as provided in division (B) of this section,	32
during and after the school year beginning in 2016, no pupil who	33
is the age or older than the age at which immunization against	34
meningococcal disease is recommended by the state department of	35
health shall be permitted to remain in a school subject to the	36
state board of education's minimum standards for more than	37
fourteen days unless the pupil presents written evidence	38
satisfactory to the person in charge of admission that the pupil	39
has been immunized by a department of health-approved method of	40
immunization, or is in the process of being immunized, against	41
meningococcal disease.	42

(4) As used in divisions (A) (1) - and (2), and (3) of this 43

section, "in the process of being immunized" means the pupil has	44
been immunized against mumps, rubeola, rubella, and chicken pox,	45
and if the pupil has not been immunized against poliomyelitis,	46
diphtheria, pertussis, tetanus, and hepatitis B, and	47
meningococcal disease, the pupil has received at least the first	48
dose of the immunization sequence, and presents written evidence	49
to the pupil's building principal or chief administrative	50
officer of each subsequent dose required to obtain immunization	51
at the intervals prescribed by the director of health. Any	52
student previously admitted under the "in process of being	53
immunized" provision and who has not complied with the	54
immunization intervals prescribed by the director of health	55
shall be excluded from school on the fifteenth day of the	56
following school year. Any student so excluded shall be	57
readmitted upon showing evidence to the student's building	58
principal or chief administrative officer of progress on the	59
director of health's interval schedule.	60

- (B)(1) A pupil who has had natural rubeola, and presents a signed statement from the pupil's parent, guardian, or physician to that effect, is not required to be immunized against rubeola.
- (2) A pupil who has had natural mumps, and presents a signed statement from the pupil's parent, guardian, or physician to that effect, is not required to be immunized against mumps.
- (3) A pupil who has had natural chicken pox, and presents a signed statement from the pupil's parent, guardian, or physician to that effect, is not required to be immunized against chicken pox.

(C) As used in this division, "chicken pox epidemic" means	79
the occurrence of cases of chicken pox in numbers greater than	80
expected in the school's population or for a particular period	81
of time.	82
Notwithstanding division (B) of this section, a school may	83
deny admission to a pupil otherwise exempted from the chicken	84
pox immunization requirement if the director of the state	85
department of health notifies the school's principal or chief	86
administrative officer that a chicken pox epidemic exists in the	87
school's population. The denial of admission shall cease when	88
the director notifies the principal or officer that the epidemic	89
no longer exists.	90
The board of education or governing body of each school	91
subject to this section shall adopt a policy that prescribes	92
methods whereby the academic standing of a pupil who is denied	93
admission during a chicken pox epidemic may be preserved.	94
(D) Boards of health, legislative authorities of municipal	95
corporations, and boards of township trustees on application of	96
the board of education of the district or proper authority of	97
any school affected by this section, shall provide at the public	98
expense, without delay, the means of immunization against mumps,	99
poliomyelitis, rubeola, rubella, diphtheria, pertussis, tetanus,	100

(E) The department of health shall specify the age at	103
which immunization against meningococcal disease, as required by	104
division (A)(3) of this section, is recommended, and approve a	105
method of immunization against meningococcal disease.	106
