In memory of Russell M. Pry.

WHEREAS, The members of the Senate of the 131st General 1
Assembly of Ohio extend our heartfelt condolences to the family 2
and friends of Russell M. Pry in their bereavement; and 3

WHEREAS, Russ Pry's zealous love of life and his selfless 4
concern for the welfare of others distinguished him as an 5
outstanding human being and a leading citizen. A councilman for 6
the Village of Mogadore, the legal counsel for the City of Boston 7
Heights and the Mogadore Local School District, as the treasurer 8
and then chairman of the Summit County Democratic Party, he was 9
the longest-serving county executive in the State of Ohio, holding 10
that position in Summit County for nearly nine years, and he was 11
instrumental in the economic growth of the area, the streamlining 12
of government services, and the creation of such community 13
initiatives as First Things First. He was a dedicated and devoted 14
public servant whose exemplary career serves as an inspiration for 15

Pry achieved a praiseworthy record of service, and his untiring 18
efforts earned him many richly deserved accolades. He gave 19
generously of his energy and abilities in all of his endeavors, 20

his family, his friends, his community, and the State of Ohio will 24

certainly live beyond him, and he will long be remembered for his 25
