## House Public Utilities Committee, Honorable Bill Seitz, Chairman

## Nita Thomas, Western Hills Community Action, Opponent Testimony to House Bill 178, Tuesday, May 16, 2017

Chairman Sietz and members of the House Public Utilities Committee, thank you for the opportunity to express my opposition today to House Bill 178.

I am Nita Thomas with Western Hills Community Action. We are a group of concerned citizens from the western side of Hamilton County, who work together to promote public policies that foster economic growth and prosperity for our community and for Ohio. I will be testifying today from the perspective of a co-leader of Western Hills Community Action, and from the perspective of someone who has had personal experience with deregulation and the benefits of competition.

I had a career in the telecommunications industry with AT&T before, during and after the dust settled in that industry's deregulation. At the time deregulation was looming, I had grave concerns, because I believed regulation was needed to provide reliable, affordable and ecologically friendly telecommunications service.

When the telecommunications industry deregulated, I was forced to face my concerns, and I came through the process with a completely different perspective. Despite my fears, I was able to stay employed by being flexible and willing to move from one office location to another and from one department to another. This process broadened my horizons and led me to departments (i.e. network engineering) I would never have otherwise ventured into. I believe that forcing competition into the telecommunications industry was a good decision and brought about many great innovations which resulted in jobs in areas never before explored or envisioned. Though I don't want to minimize the transition pains that any family felt at the time, the facts are that deregulation led to technological advances, lower costs, and telecommunications options today that we never could have dreamed of 20 years ago.

That experience helped shape my now staunch belief that markets work best, and consumers benefit most when the government allows competition to work. That belief is one of the driving reasons behind why I helped found and why I co-lead Western Hills Community Action. It is also why I am here today.

I, and the members of Western Hills Community Action, believe that same principal of competition applies in the power generation market. Though Ohio's power generation market deregulated several years ago, utility companies continue to ask for subsidies, special fees, and bailouts that interfere with the free market, give these companies a leg up, and discourage private investment in power generation in Ohio. We ask you to please say no to this government intervention, and let the free market work.

While I and the members of our organization do not live in FirstEnergy's territory, and would not be subject to direct rate hikes from this legislation, we are concerned about the impact this legislation could have on all ratepayers across Ohio if it drives investment in lower cost power generation out of the state. And, we staunchly oppose this legislation because it is anti-free market and anti-competition.

To demonstrate the opposition to this legislation in Southwest, Ohio, over the past few days Western Hills Community Action has collected the names of the 153 below-listed individuals who also oppose the legislation, and who support our efforts today in asking this committee to reject House Bill 178.
