

## State and Local Government Proponent Testimony – House Bill 319 October 10, 2017

Chairman Anielski, Vice Chairman Hambley, Ranking Member Holmes and members of the committee, my name is Corey Roscoe and I am the State Director for the Humane Society of the United States (HSUS) the nation's largest and most effective animal protection organization. On behalf of the HSUS and our Ohio members and supporters, I offer Proponent testimony on House Bill 319, designate a shelter pet as the official state pet.

Dogs and cats share the homes of 65% of U.S. households, providing many benefits to their families such as love, loyalty and an improved sense of well-being. Yet many people are surprised to learn that nationwide, more than 2.4 million healthy, adoptable cats and dogs are euthanized in shelters annually due to a lack of critical resources and public awareness.

Shelter animals make great pets. When families choose to adopt, they save a loving animal by making them part of their family and open up shelter space for another animal who might desperately need it.

If more families looking for a pet this year would adopt their new furry friend from a shelter, we could reduce the number of pets euthanized at shelters. Animal shelters and rescue groups are brimming with happy, healthy pets just waiting for someone to take them home. With the help of legislation like House Bill 319, we can spread the word about the benefits of adoption and work to end the senseless euthanasia of homeless pets nationwide.
