In his 61 years, Michael Frederick, DVM never once waived from his goal of becoming a veterinarian and fulfilling his lifelong desire to help animals. Born in Southwestern Ohio and a lifelong resident of Hamilton County, Michael Frederick graduated the valedictorian of his class from Harrison High School in 1970 and in just 6 years graduated from the Ohio State University with his Doctorate of Veterinarian Medicine (DVM). His scholastic achievements alone gained him admission to the Mensa International, a society for individuals with high IQ percentages.

Licensed to practice veterinary medicine in the states of Ohio, Indiana, and Kentucky, Michael Frederick, DVM first practiced medicine as an associate veterinarian for two mixed animal practices before designing and opening his own practice, Miamitown Pet Hospital in 1985. Located on St Rt. 128, Miamitown Pet Hospital matured into a robust three veterinarian large and small animal hospital practice supported by three specially equipped medical mobile vans used to provide on-site medical care to farm animals.

An active Ohio Farm Bureau member, Dr. Frederick held the position of Vice-President and Public Policy Chairman for the Hamilton County Farm Bureau. He strongly supports and promotes Ohio Farm Bureau membership to the farm residents of Hamilton County. Dr. Frederick is a member of the Board of Directors for the Hamilton County Fair and for over 20 years has donated uncountable hours fulfilling the duties of being the official veterinarian for the Hamilton County Fair as well as additional tri-state 4-H Community Fairs. Dr. Frederick received the prestigious P.B. Johnston Award from the Society of Prevention of Cruelty to Animals (SPCA) for his humanitarian aid involving his work with abused dairy cattle. Dr. Frederick is an active member of the American Association of Equine Practitioners (AAEP), the Ohio Veterinary Medical Association (OVMA), the Cincinnati Veterinary Medical Association (CVMA), the American Veterinary Medical Association (AVMA), Cincinnati SPCA Board of Directors, and the SPCA Cincinnati Simmonds Farm Committee chairman.

When not helping animals, Dr. Frederick, an accomplished general aviation pilot enjoys flying his airplane, working on his small horse farm, and spending time with his wife Ann, his two daughters Meredith and Kristin, and his multiple household pets.
