We would like to vehemently express our opposition to HB49. As parents, it is our duty and right to make medical decisions for our children as we see fit. It is our understanding that the AAP wishes to eliminate all vaccine exemption rights for parents. It is not the right of the AAP to determine that we must have a doctors signature or approval on a medical decision or to require vaccine exemption tracking, which we see a serious violation of our privacy. Their doctor members benefit significantly from the usage of vaccines, which is a serious conflict of interest in this matter. We are living in a highly politicized environment on the subject of vaccines and the facts are becoming lost in this political debate. As you consider this issue, I would ask you some questions:

-Are you aware that vaccine manufacturers face zero liability for any death or injuries that occur due to their products since 1986?

-Are you aware that the government National Vaccine Injury Compensation Fund has paid out almost 4 Billion dollars to date to vaccine injured families and individuals?

-Are you aware that the manufacturers inserts list many serious adverse reactions to vaccines including - pancreatitis, vasculitis, diabetes, thrombocytopenia, encephalitis, Guillain-Barre Syndrome, seizures, and more?

-Are you aware that the current vaccine schedule has never been tested in combination?

-Are you aware that the ingredients in various vaccines include - formaldehyde, aluminum, mercury, aborted fetal cells, and polysorbate 80?

-Knowing these above concerns, do you still feel that the government has the final say as to what is injected into our children? Parents do not need to be harassed, coerced, or 'reeducated' regarding vaccines. Parents who opt out of vaccines, or choose to delay vaccines, for their children do copious research and have come to their own decisions after studying the above factors, more research than many physicians themselves have done. Most pediatricians are not even aware of the VAERS (Vaccine Adverse Event Reporting System), a passive reporting system because there is no punishment for not reporting vaccine injury, therefore their patients do not either. All of the above points can be easily found through a google search, this is not classified information.
