Dear Senator/Representative:

Please vote NO on House Bill 49. Your action is needed to stop an effort to attach an amendment to a [budget bill](#) (HB 49) that would force parents to have their exemptions signed by a physician and to allow for standardizing and collection of vaccine exemption data.

Forcing additional physician visits for exemption forms will increase the healthcare expenditures for our citizens at a time where rising costs for healthcare is skyrocketing and causing much concern.

Contrary to what proponents of vaccines tell us, there have been no real definitive, unbiased studies proving the safety of vaccines. In fact our government has termed them **unavoidably unsafe**.
