My disabled child was and last I checked still required to do the impossible. This is precedent in the State of Ohio and is the law of the land. The paperwork was easier, I guess.

I have a state hearing, on a denial that does not say it is a denial but an unsigned form letter. The paperwork is easier, I guess.

I have another denial, another form letter but the blank to fill in was just skipped, the paperwork is easier, I guess.

The government found it easier to blame me for an underweight child. In order to have my children it required me to have "supervision" which limited my ability to do anything. When my child would no longer even drink, he was hospitalized. The supervision, was required because I am a Christian. The old saying is, If you were accused of being Christian would you be convicted. I almost was. I said to a doctor in the middle of the night, "Matthew is dying, everyone that knows him know it, why don't you know it."

Medicaid families cannot have assets except with narrow allowances.
