**SUMMARY of EXPERIENCE:** A community leader in the private, public and nonprofit arena. A 28 year business innovator and entrepreneurial manager in the food, beverage, hospitality and service industries, transitioning into the social service, aging network, along with public service as an elected official. Proven skills in United Way and aging network, collaborative innovations, development of new methods of service, sustainability and fundraising. Leader in business restaurant/hospitality conceptualization, start-up, marketing, advertising, employee management, training, customer service, planning, production, and execution.

### **KEY PROFESSIONAL ACCOMPLISHMENTS**

- Led United Way of Hancock County through a record breaking annual campaign eclipsing \$3,030,000 in first year as CEO. We also raised an additional \$140,000 non campaign dollar for our Halt Hunger Initiative for the first time in the three year existence of the initiative.
- Led staff of seven through our newly created strategic planning process with the emphasis on moving to collective impact over the next 3-5 years.
- Am a group leader for the newly created U.S. Network Engagement Corps and have been actively involved at a regional and national level in my first two years with United Way..
- Direct social service agency for seniors of Hancock County employing 23 staff with an annual budget of \$1,500,000, an increase \$850,000 in six years. We accomplished this in challenging economic times relying on less public funding while maintaining an administrative expense of 13%.
- Drove a 300% increase in services over six years
- Led the passage of a senior service levy in 2011 by 72%
- Impacted the lives of 48% of seniors in Hancock County and increased services from 18,500 in 2006 to 77,000 in 2011
- Designed and led Capital Campaign that raised \$1,130,000 in 2010.
- Created Senior Café dining program in 2007. Grew congregate dining from 4,400 meals served in 2006 to 22,948 served in 2007. The agency also showed an overall increase of 30% in services provided during the same time period.
- Developed and implemented sustainable fitness and wellness programming in 2009 through grants and donations. Fitness participation grew from 4,400 activities in 2010 to 16,250 in 2011 while membership increased from 425 to 770 in the same time period.
- Work effectively with Board of Trustees in creation and implementation of annual strategic plan
- Unseated 12 year incumbent in fall of 2011 by a margin of 68% in election for City Council President
