Chairman Burke and members of the Senate Health, Human Services, and Medicaid Committee, thank you for allowing me to give testimony to Am. Sub. HB 258, the Heartbeat Bill. It is a pleasure and a privilege to come before you, with my joint sponsor Representative Hagan, to discuss the merits of this bill with you today.

The bipartisan Heartbeat Bill makes the simple statement that we, Ohioans, believe that if you have a heartbeat, you have life - life that demands protection.

The Founding Fathers of our country also believed that as human beings, we had the right to life. For example, Thomas Jefferson wrote in the Declaration of Independence,

“We hold these truths to be self-evident, that all men are created equal, that they are endowed by their Creator with certain inalienable Rights, that among these are **Life**, Liberty and the pursuit of Happiness.”

Additionally, in the 14th Amendment to the Constitution of the United States it is written,

“No state shall make or enforce any law which shall abridge the privileges or immunities of citizens of the United States; nor shall any state deprive any person of **life**, liberty, or property, without due process of law; nor deny to any person within its jurisdiction the equal protection of the laws.”

The belief that a living human being has rights and value is not a foreign concept. These truths have been espoused since the founding of our nation and before.

A report recently released by the Ohio Department of Health found that there were 20,893 induced abortions in Ohio over the course of 2017. An increase of 1% over the amount of abortions performed in Ohio in 2016. This amounts to approximately two
