(B) The grant's current and future impact to district or
school programs, finances, and faculty;

(C) A web site link to the grant;

(D) An online copy of the grant application submitted by the

district or school."

"Sec. 3319.324. (A) Each school district or school shall disclose all student digital applications, platforms, or any online programs that are used in student instruction, guidance, collaboration, or administration. The disclosure shall be distributed to parents at the beginning of each school year, shall be organized by grade level, and shall be posted on the district's or school's web site.

(B) In the disclosure, each district or school shall provide the following:

(1) The purpose of student digital applications, platforms, or programs used by the district or school;

(2) All information and data points collected on students;

(3) The specific use of information by a teacher and other individuals with regard to digital applications, platforms, or programs;

(4) The identities of any vendors or parties involved in the collection, retention, or use of student data collected by digital applications, platforms, or programs;

(5) The retention and destruction policies for student data collected by student digital applications, platforms, or programs;

(6) Access to the web site of student digital applications, platforms, or programs;

(7) An acknowledgment of and provision for parental access to student digital applications, platforms, or programs;

(8) An opt-out form from student participation in student 73
digital applications, platforms, or programs; 74

(9) An acknowledgment that traditional instruction shall be 75
provided for students who opt out of student digital applications, 76
platforms, or programs." 77
