То	enact sections 3727.11, 3727.12, 3727.13,	1
	3727.14, 3727.15, and 4765.401 of the Revised	2
	Code to provide for recognition of stroke	3
	centers and establishment of protocols for	4
	assessment, treatment, and transport to	5
	hospitals of stroke patients.	6

#### BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

Section 1. That sections 3727.11, 3727.12, 3727.13,	7
3727.14, 3727.15, and 4765.401 of the Revised Code be enacted to	8
read as follows:	9
Sec. 3727.11. A hospital shall not represent itself as a	10
comprehensive stroke center, primary stroke center, or acute	11
stroke ready hospital unless it is recognized as such by the	12
department of health under section 3727.13 of the Revised Code.	13

This section does not prohibit a hospital from	14
representing itself as having a relationship or affiliation with	15
a hospital recognized by the department of health under section	16
3727.13 of the Revised Code.	17
Sec. 3727.12. (A) A person or government entity seeking	18
recognition of a hospital as a comprehensive stroke center,	19
primary stroke center, or acute stroke ready hospital by the	20
department of health under section 3727.13 of the Revised Code	21
shall file with the department an application for recognition.	22
The application shall be submitted in the manner prescribed by	23
the department.	24
(B)(1) To be eligible for recognition as a comprehensive	25
stroke center under section 3727.13 of the Revised Code, a	26
hospital must be certified as a comprehensive stroke center by	27
an accrediting organization approved by the federal centers for	28
medicare and medicaid services or an organization acceptable to	29
the department under division (C) of this section.	30
(2) To be eligible for recognition as a primary stroke	31
center under section 3727.13 of the Revised Code, a hospital	32
must be certified as a primary stroke center by an accrediting	33
organization approved by the federal centers for medicare and	34
medicaid services or an organization acceptable to the	35
department under division (C) of this section.	36
(3) To be eligible for recognition as an acute stroke	37
ready hospital under section 3727.13 of the Revised Code, a	38
hospital must be certified as an acute stroke ready hospital by	39
an accrediting organization approved by the federal centers for	40
medicare and medicaid services or an organization acceptable to	41
the department under division (C) of this section.	42

(C) For purposes of division (B) of this section, to be	43
acceptable to the department an organization must certify	44
comprehensive stroke centers, primary stroke centers, or acute	45
stroke ready hospitals in accordance with nationally recognized	46
certification guidelines.	47
Sec. 3727.13. (A) (1) The department of health shall	48
recognize as a comprehensive stroke center a hospital that	49
satisfies the requirements of division (B)(1) of section 3727.12	50
of the Revised Code and submits a complete application.	51
(2)(a) The department shall recognize as a primary stroke	52
center a hospital that satisfies the requirements of division	53
(B) (2) of section 3727.12 of the Revised Code and submits a	54
complete application.	55
(b) If a hospital satisfying the requirements of division	56
(B) (2) of section 3727.12 of the Revised Code has attained	57
supplementary levels of stroke care distinction as identified by	58
an accrediting organization approved by the federal centers for	59
medicare and medicaid services or an organization accepted by	60
the department under section 3727.12 of the Revised Code,	61
including by offering patients mechanical endovascular therapy,	62
the department shall include that distinction in its	63
recognition.	64
(3) The department shall recognize as an acute stroke	65
ready hospital a hospital that satisfies the requirements of	66
division (B)(3) of section 3727.12 of the Revised Code and	67
submits a complete application.	68
(B) Pursuant to an adjudication conducted under Chapter	69
119. of the Revised Code, the department may suspend or revoke a	70
hospitalls recognition under division (A) of this section if it	71

determines that the hospital no longer satisfies the	
requirements for recognition.	73
(C) Not later than the first day of June each year, the	74
department shall compile and send a list of hospitals recognized	75
under division (A) of this section to the medical director and	76
cooperating physician advisory board of each emergency medical	77
service organization, as defined in section 4765.01 of the	78
Revised Code. The department also shall post the list on its	79
internet web site.	80
Sec. 3727.14. If an accrediting organization approved by	81
the federal centers for medicare and medicaid services or an	82
organization that certifies hospitals in accordance with	83
nationally recognized certification quidelines establishes a	84
level of stroke certification that is in addition to the three	85
levels described in sections 3727.11 to 3727.13 of the Revised	86
Code, the department of health shall recognize a hospital	87
certified at that additional level.	88
For purposes of this section, the department and a	89
hospital shall comply with sections 3727.11 to 3727.13 of the	90
Revised Code as if the certification and recognition described	91
in this section were one of the three levels described in	92
sections 3727.11 to 3727.13 of the Revised Code.	93
Sec. 3727.15. The director of health shall adopt rules as	94
the director considers necessary for the implementation of	95
sections 3727.11 to 3727.14 of the Revised Code. The rules shall	96
be adopted in accordance with Chapter 119. of the Revised Code.	97
Sec. 4765.401. (A) The medical director or cooperating	98
physician advisory board of each emergency medical service	99
organization shall establish written protocols for the	100

assessment, treatment, and transport to hospitals of stroke	101
patients by emergency medical service personnel. In establishing	102
protocols, the medical director or cooperating physician	103
advisory board shall consult with one or more local hospitals.	104
(B) Each emergency medical service organization shall	105
provide copies of its protocols to the department of health; the	106
state board of emergency medical, fire, and transportation	107
services; and the regional director or regional advisory board	108
appointed under section 4765.05 of the Revised Code for the	109
organization's emergency medical services region.	110
