No person shall hold the office of state senator for a-29 period longer more than two successive terms of four years. No 30 person shall hold the office of state representative for a-31 period longer more than four successive terms of two years. 32 Terms shall be considered successive unless separated by a 33 period of four or more years. Only terms beginning on or after 34 January 1, 1993 shall be considered in determining an-35 individual's eligibility to hold office. No person shall hold the 36 office of state senator or state representative for more than 37 eight years, and no person shall serve as a member of the 38 general assembly for more than sixteen years collectively. 39

In determining the eligibility of an individual to hold an 40 office in accordance with under this article, (A) time spent in 41 an office in fulfillment of a term to which another person was 42 first elected shall not be considered provided that a period of 43 at least four years passed between the time, if any, in which-44 the individual previously held that office, and the time the 45 individual is elected or appointed to fulfill the unexpired-46 term; both a person appointed to an office to fulfill a term to 47 which another person was first elected and (B) a person who is 48 elected to an office in a regularly scheduled general election 49 and resigns prior to the completion of the term for which he or 50 she was elected, shall be considered to have served the full 51
