**A BILL**

To amend sections 4501.21, 4503.772, and 4503.98 1  
and to enact sections 1546.30, 4503.435, 2  
4503.436, 4503.4910, 4503.4911, 4503.566, 3  
4503.593, 4503.594, 4503.764, 4503.873, 4  
4503.875, 4503.876, 4503.878, 4503.879, 4503.88, 5  
4503.891, 4503.892, 4503.905, 4503.906, 6  
4503.907, 4503.908, 4503.951, 5534.151, 7  
5534.411, 5534.412, 5534.413, 5534.48, 5534.491, 8  
5534.494, 5534.56, 5534.57, 5534.58, 5534.631, 9  
5534.64, 5534.69, 5534.76, 5534.78, 5534.801, 10

**BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:**

**Section 1.** That sections 4501.21, 4503.772, and 4503.98 of 17  
the Revised Code be amended and sections 1546.30, 4503.435, 18  
4503.436, 4503.4910, 4503.4911, 4503.566, 4503.593, 4503.594, 19  
4503.764, 4503.873, 4503.875, 4503.876, 4503.878, 4503.879, 20  
4503.88, 4503.891, 4503.892, 4503.905, 4503.906, 4503.907, 21  
4503.908, 4503.951, 5534.151, 5534.411, 5534.412, 5534.413, 22  
5534.48, 5534.491, 5534.494, 5534.56, 5534.57, 5534.58, 23  
5534.631, 5534.64, 5534.69, 5534.76, 5534.78, 5534.801, 24  
5534.802, 5534.803, 5534.804, 5534.84, 5534.86, 5534.87, 25  
5534.88, 5534.93, 5534.95, and 5534.97 of the Revised Code be 26  
enacted to read as follows: 27

**Sec. 1546.30.** The picnic area that is located northwest of 28  
the intersection of Titus road and Division street in Kelleys 29  
Island state park shall be known as the "Henry T. Beatty 30  
Memorial Picnic Area." 31

The chief of the division of parks and watercraft may 32  
erect suitable markers in the picnic area indicating its name. 33

**Sec. 4501.21.** (A) There is hereby created in the state 34  
treasury the license plate contribution fund. The fund shall 35  
consist of all contributions paid by motor vehicle registrants 36  
and collected by the registrar of motor vehicles pursuant to 37  
sections 4503.491, 4503.492, 4503.493, 4503.494, 4503.495, 38  
4503.496, 4503.497, 4503.498, 4503.499, 4503.4910, 4503.4911, 39  
4503.50, 4503.501, 4503.502, 4503.505, 4503.51, 4503.514, 40

4503.521, 4503.522, 4503.523, 4503.524, 4503.525, 4503.526, 41

(B) The registrar shall pay the contributions the 55  
registrar collects in the fund as follows: 56

The registrar shall pay the contributions received 57  
pursuant to section 4503.491 of the Revised Code to the breast 58  
cancer fund of Ohio, which shall use that money only to pay for 59  
programs that provide assistance and education to Ohio breast 60  
cancer patients and that improve access for such patients to 61  
quality health care and clinical trials and shall not use any of 62  
the money for abortion information, counseling, services, or 63  
other abortion-related activities. 64

The registrar shall pay the contributions the registrar 65  
receives pursuant to section 4503.492 of the Revised Code to the 66  
organization cancer support community central Ohio, which shall 67  
deposit the money into the Sheryl L. Kraner Fund of that 68  
organization. Cancer support community central Ohio shall expend 69  
the money it receives pursuant to this division only in the same 70

manner and for the same purposes as that organization expends 71  
other money in that fund. 72

The registrar shall pay the contributions received 73  
pursuant to section 4503.493 of the Revised Code to the autism 74  
society of Ohio, which shall use the contributions for programs 75  
and autism awareness efforts throughout the state. 76

The registrar shall pay the contributions the registrar 77  
receives pursuant to section 4503.494 of the Revised Code to the 78  
national multiple sclerosis society for distribution in equal 79  
amounts to the northwestern Ohio, Ohio buckeye, and Ohio valley 80  
chapters of the national multiple sclerosis society. These 81  
chapters shall use the money they receive under this section to 82  
assist in paying the expenses they incur in providing services 83  
directly to their clients. 84

The registrar shall pay the contributions the registrar 85  
receives pursuant to section 4503.495 of the Revised Code to the 86  
national pancreatic cancer foundation, which shall use the money 87  
it receives under this section to assist those who suffer with 88  
pancreatic cancer and their families. 89

The registrar shall pay the contributions the registrar 90  
receives pursuant to section 4503.496 of the Revised Code to the 91  
Ohio sickle cell and health association, which shall use the 92  
contributions to help support educational, clinical, and social 93  
support services for adults who have sickle cell disease. 94

The registrar shall pay the contributions the registrar 95  
receives pursuant to section 4503.497 of the Revised Code to the 96  
St. Baldrick's foundation, which shall use the contributions for 97  
its research and other programs. 98

The registrar shall pay the contributions the registrar 99

receives pursuant to section 4503.498 of the Revised Code to 100  
special olympics Ohio, inc., which shall use the contributions 101  
for its programs, charitable efforts, and other activities. 102

The registrar shall pay the contributions the registrar 103  
receives pursuant to section 4503.499 of the Revised Code to the 104  
children's glioma cancer foundation, which shall use the 105  
contributions for its research and other programs. 106

The registrar shall pay the contributions the registrar 107  
receives pursuant to section 4503.4910 of the Revised Code to 108  
the KylerStrong foundation, which shall use the contributions to 109  
raise awareness of brain cancer caused by diffuse intrinsic 110  
pontine glioma and to fund research for the cure of such cancer. 111

The registrar shall pay the contributions the registrar 112  
receives pursuant to section 4503.4911 of the Revised Code to 113  
the research institution for childhood cancer at nationwide 114  
children's hospital, which shall use the contributions to fund 115  
research for the cure of childhood cancers. 116

The registrar shall pay the contributions the registrar 117  
receives pursuant to section 4503.50 of the Revised Code to the 118  
future farmers of America foundation, which shall deposit the 119  
contributions into its general account to be used for 120  
educational and scholarship purposes of the future farmers of 121  
America foundation. 122

The registrar shall pay the contributions the registrar 123  
receives pursuant to section 4503.501 of the Revised Code to the 124  
4-H youth development program of the Ohio state university 125  
extension program, which shall use those contributions to pay 126  
the expenses it incurs in conducting its educational activities. 127

The registrar shall pay the contributions received 128

pursuant to section 4503.502 of the Revised Code to the Ohio 129  
cattlemen's foundation, which shall use those contributions for 130  
scholarships and other educational activities. 131

The registrar shall pay the contributions received 132  
pursuant to section 4503.505 of the Revised Code to the 133  
organization Ohio region phi theta kappa, which shall use those 134  
contributions for scholarships for students who are members of 135  
that organization. 136

The registrar shall pay each contribution the registrar 137  
receives pursuant to section 4503.51 of the Revised Code to the 138  
university or college whose name or marking or design appears on 139  
collegiate license plates that are issued to a person under that 140  
section. A university or college that receives contributions 141  
from the fund shall deposit the contributions into its general 142  
scholarship fund. 143

The registrar shall pay the contributions the registrar 144  
receives pursuant to section 4503.514 of the Revised Code to the 145  
university of Notre Dame in South Bend, Indiana, for purposes of 146  
awarding grants or scholarships to residents of Ohio who attend 147  
the university. The university shall not use any of the funds it 148  
receives for purposes of administering the scholarship program. 149  
The registrar shall enter into appropriate agreements with the 150  
university of Notre Dame to effectuate the distribution of such 151  
funds as provided in this section. 152

The registrar shall pay the contributions the registrar 153  
receives pursuant to section 4503.521 of the Revised Code to the 154  
Ohio bicycle federation to assist that organization in paying 155  
for the educational programs it sponsors in support of Ohio 156  
cyclists of all ages. 157

The registrar shall pay the contributions the registrar receives pursuant to section 4503.522 of the Revised Code to the "friends of Perry's victory and international peace memorial, incorporated," a nonprofit corporation organized under the laws of this state, to assist that organization in paying the expenses it incurs in sponsoring or holding charitable, educational, and cultural events at the monument.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.523 of the Revised Code to the fairport lights foundation, which shall use the money to pay for the restoration, maintenance, and preservation of the lighthouses of fairport harbor.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.524 of the Revised Code to the Massillon tiger football booster club, which shall use the contributions only to promote and support the football team of Washington high school of the Massillon city school district.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.525 of the Revised Code to the United States power squadron districts seven, eleven, twenty-four, and twenty-nine in equal amounts. Each power squadron district shall use the money it receives under this section to pay for the educational boating programs each district holds or sponsors within this state.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.526 of the Revised Code to the Ohio district Kiwanis foundation of the Ohio district of Kiwanis international, which shall use the money it receives under this section to pay the costs of its educational and humanitarian activities.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.528 of the Revised Code to the Ohio association of child caring agencies, which shall use the money it receives under this section to pay the expenses it incurs in advancing its mission of sustainably improving the provision of services to children, young adults, and families in this state.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.529 of the Revised Code to the Ohio nurses foundation. The foundation shall use the money it receives under this section to provide educational scholarships to assist individuals who aspire to join the nursing profession, to assist nurses in the nursing profession who seek to advance their education, and to support persons conducting nursing research concerning the evidence-based practice of nursing and the improvement of patient outcomes.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.531 of the Revised Code to the thank you foundation, incorporated, a nonprofit corporation organized under the laws of this state, to assist that organization in paying for the charitable activities and programs it sponsors in support of United States military personnel, veterans, and their families.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.534 of the Revised Code to the disabled American veterans department of Ohio, to be used for programs that serve disabled American veterans and their families.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.55 of the Revised Code to the

pro football hall of fame, which shall deposit the contributions 218  
into a special bank account that it establishes and which shall 219  
be separate and distinct from any other account the pro football 220  
hall of fame maintains, to be used exclusively for the purpose 221  
of promoting the pro football hall of fame as a travel 222  
destination. 223

The registrar shall pay the contributions that are paid to 224  
the registrar pursuant to section 4503.545 of the Revised Code 225  
to the national rifle association foundation, which shall use 226  
the money to pay the costs of the educational activities and 227  
programs the foundation holds or sponsors in this state. 228

The registrar shall pay to the Ohio pet fund the 229  
contributions the registrar receives pursuant to section 230  
4503.551 of the Revised Code and any other money from any other 231  
source, including donations, gifts, and grants, that is 232  
designated by the source to be paid to the Ohio pet fund. The 233  
Ohio pet fund shall use the moneys it receives under this 234  
section to support programs for the sterilization of dogs and 235  
cats and for educational programs concerning the proper 236  
veterinary care of those animals, and for expenses of the Ohio 237  
pet fund that are reasonably necessary for it to obtain and 238  
maintain its tax-exempt status and to perform its duties. 239

The registrar shall pay the contributions the registrar 240  
receives pursuant to section 4503.552 of the Revised Code to the 241  
rock and roll hall of fame and museum, incorporated. 242

The registrar shall pay the contributions the registrar 243  
receives pursuant to section 4503.553 of the Revised Code to the 244  
Ohio coalition for animals, incorporated, a nonprofit 245  
corporation. Except as provided in division (B) of this section, 246  
the coalition shall distribute the money to its members, and the 247

members shall use the money only to pay for educational, 248  
charitable, and other programs of each coalition member that 249  
provide care for unwanted, abused, and neglected horses. The 250  
Ohio coalition for animals may use a portion of the money to pay 251  
for reasonable marketing costs incurred in the design and 252  
promotion of the license plate and for administrative costs 253  
incurred in the disbursement and management of funds received 254  
under this section. 255

The registrar shall pay the contributions the registrar 256  
receives pursuant to section 4503.554 of the Revised Code to the 257  
Ohio state council of the knights of Columbus, which shall use 258  
the contributions to pay for its charitable activities and 259  
programs. 260

The registrar shall pay the contributions the registrar 261  
receives pursuant to section 4503.555 of the Revised Code to the 262  
western reserve historical society, which shall use the 263  
contributions to fund the Crawford auto aviation museum. 264

The registrar shall pay the contributions the registrar 265  
receives pursuant to section 4503.556 of the Revised Code to the 266  
Erica J. Holloman foundation, inc., for the awareness of triple 267  
negative breast cancer. The foundation shall use the 268  
contributions for charitable and educational purposes. 269

The registrar shall pay the contributions the registrar 270  
receives pursuant to section 4503.561 of the Revised Code to the 271  
state of Ohio chapter of ducks unlimited, inc., which shall 272  
deposit the contributions into a special bank account that it 273  
establishes. The special bank account shall be separate and 274  
distinct from any other account the state of Ohio chapter of 275  
ducks unlimited, inc., maintains and shall be used exclusively 276  
for the purpose of protecting, enhancing, restoring, and 277

managing wetlands and conserving wildlife habitat. The state of 278  
Ohio chapter of ducks unlimited, inc., annually shall notify the 279  
registrar in writing of the name, address, and account to which 280  
such payments are to be made. 281

The registrar shall pay the contributions the registrar 282  
receives pursuant to section 4503.562 of the Revised Code to the 283  
Mahoning river consortium, which shall use the money to pay the 284  
expenses it incurs in restoring and maintaining the Mahoning 285  
river watershed. 286

The registrar shall pay the contributions the registrar 287  
receives pursuant to section 4503.564 of the Revised Code to 288  
Antioch college for the use of the Glen Helen ecology institute 289  
to pay expenses related to the Glen Helen nature preserve. 290

The registrar shall pay the contributions the registrar 291  
receives pursuant to section 4503.565 of the Revised Code to the 292  
conservancy for Cuyahoga valley national park, which shall use 293  
the money in support of the park. 294

The registrar shall pay the contributions the registrar 295  
receives pursuant to section 4503.566 of the Revised Code to the 296  
Ottawa national wildlife refuge, which shall use the 297  
contributions for wildlife preservation purposes. 298

The registrar shall pay the contributions the registrar 299  
receives pursuant to section 4503.576 of the Revised Code to the 300  
Ohio state beekeepers association, which shall use those 301  
contributions to promote beekeeping, provide educational 302  
information about beekeeping, and to support other state and 303  
local beekeeping programs. 304

The registrar shall pay the contributions the registrar 305  
receives pursuant to section 4503.577 of the Revised Code to the 306

national aviation hall of fame, which shall use the 307  
contributions to fulfill its mission of honoring aerospace 308  
legends to inspire future leaders. 309

The registrar shall pay to a sports commission created 310  
pursuant to section 4503.591 of the Revised Code each 311  
contribution the registrar receives under that section that an 312  
applicant pays to obtain license plates that bear the logo of a 313  
professional sports team located in the county of that sports 314  
commission and that is participating in the license plate 315  
program pursuant to division (E) of that section, irrespective 316  
of the county of residence of an applicant. 317

The registrar shall pay to a community charity each 318  
contribution the registrar receives under section 4503.591 of 319  
the Revised Code that an applicant pays to obtain license plates 320  
that bear the logo of a professional sports team that is 321  
participating in the license plate program pursuant to division 322  
(G) of that section. 323

The registrar shall pay the contributions the registrar 324  
receives pursuant to section 4503.592 of the Revised Code to 325  
pollinator partnership's monarch wings across Ohio program, 326  
which shall use the contributions for the protection and 327  
preservation of the monarch butterfly and pollinator corridor in 328  
Ohio and for educational programs. 329

The registrar shall pay the contributions the registrar 330  
receives pursuant to section 4503.594 of the Revised Code to 331  
pelotonia, which shall use the contributions for the purpose of 332  
supporting cancer research. 333

The registrar shall pay the contributions the registrar 334  
receives pursuant to section 4503.67 of the Revised Code to the 335

Dan Beard council of the boy scouts of America. The council 336  
shall distribute all contributions in an equitable manner 337  
throughout the state to regional councils of the boy scouts. 338

The registrar shall pay the contributions the registrar 339  
receives pursuant to section 4503.68 of the Revised Code to the 340  
great river council of the girl scouts of the United States of 341  
America. The council shall distribute all contributions in an 342  
equitable manner throughout the state to regional councils of 343  
the girl scouts. 344

The registrar shall pay the contributions the registrar 345  
receives pursuant to section 4503.69 of the Revised Code to the 346  
Dan Beard council of the boy scouts of America. The council 347  
shall distribute all contributions in an equitable manner 348  
throughout the state to regional councils of the boy scouts. 349

The registrar shall pay the contributions the registrar 350  
receives pursuant to section 4503.701 of the Revised Code to the 351  
Prince Hall grand lodge of free and accepted masons of Ohio, 352  
which shall use the contributions for scholarship purposes. 353

The registrar shall pay the contributions the registrar 354  
receives pursuant to section 4503.702 of the Revised Code to the 355  
Ohio Association of the Improved Benevolent and Protective Order 356  
of the Elks of the World, which shall use the funds for 357  
charitable purposes. 358

The registrar shall pay the contributions the registrar 359  
receives pursuant to section 4503.71 of the Revised Code to the 360  
fraternal order of police of Ohio, incorporated, which shall 361  
deposit the fees into its general account to be used for 362  
purposes of the fraternal order of police of Ohio, incorporated. 363

The registrar shall pay the contributions the registrar 364

receives pursuant to section 4503.711 of the Revised Code to the 365  
fraternal order of police of Ohio, incorporated, which shall 366  
deposit the contributions into an account that it creates to be 367  
used for the purpose of advancing and protecting the law 368  
enforcement profession, promoting improved law enforcement 369  
methods, and teaching respect for law and order. 370

The registrar shall pay the contributions received 371  
pursuant to section 4503.712 of the Revised Code to Ohio 372  
concerns of police survivors, which shall use those 373  
contributions to provide whatever assistance may be appropriate 374  
to the families of Ohio law enforcement officers who are killed 375  
in the line of duty. 376

The registrar shall pay the contributions received 377  
pursuant to section 4503.713 of the Revised Code to the greater 378  
Cleveland peace officers memorial society, which shall use those 379  
contributions to honor law enforcement officers who have died in 380  
the line of duty and support its charitable purposes. 381

The registrar shall pay the contributions the registrar 382  
receives pursuant to section 4503.715 of the Revised Code to the 383  
fallen linemen organization, which shall use the contributions 384  
to recognize and memorialize fallen linemen and support their 385  
families. 386

The registrar shall pay the contributions the registrar 387  
receives pursuant to section 4503.72 of the Revised Code to the 388  
organization known on March 31, 2003, as the Ohio CASA/GAL 389  
association, a private, nonprofit corporation organized under 390  
Chapter 1702. of the Revised Code. The Ohio CASA/GAL association 391  
shall use these contributions to pay the expenses it incurs in 392  
administering a program to secure the proper representation in 393  
the courts of this state of abused, neglected, and dependent 394

children, and for the training and supervision of persons 395  
participating in that program. 396

The registrar shall pay the contributions the registrar 397  
receives pursuant to section 4503.722 of the Revised Code to the 398  
Down Syndrome Association of Central Ohio, which shall use the 399  
contributions for advocacy purposes throughout the state. 400

The registrar shall pay the contributions the registrar 401  
receives pursuant to section 4503.73 of the Revised Code to 402  
Wright B. Flyer, incorporated, which shall deposit the 403  
contributions into its general account to be used for purposes 404  
of Wright B. Flyer, incorporated. 405

The registrar shall pay the contributions the registrar 406  
receives pursuant to section 4503.732 of the Revised Code to the 407  
Siegel & Shuster society, a nonprofit organization dedicated to 408  
commemorating and celebrating the creation of Superman in 409  
Cleveland, Ohio. 410

The registrar shall pay the contributions the registrar 411  
receives pursuant to section 4503.733 of the Revised Code to the 412  
central Ohio chapter of the juvenile diabetes research 413  
foundation, which shall distribute the contributions to the 414  
chapters of the juvenile diabetes research foundation in whose 415  
geographic territory the person who paid the contribution 416  
resides. 417

The registrar shall pay the contributions the registrar 418  
receives pursuant to section 4503.74 of the Revised Code to the 419  
Columbus zoological park association, which shall disburse the 420  
moneys to Ohio's major metropolitan zoos, as defined in section 421  
4503.74 of the Revised Code, in accordance with a written 422  
agreement entered into by the major metropolitan zoos. 423

The registrar shall pay the contributions the registrar 424  
receives pursuant to section 4503.75 of the Revised Code to the 425  
rotary foundation, located on March 31, 2003, in Evanston, 426  
Illinois, to be placed in a fund known as the permanent fund and 427  
used to endow educational and humanitarian programs of the 428  
rotary foundation. 429

The registrar shall pay the contributions the registrar 430  
receives pursuant to section 4503.751 of the Revised Code to the 431  
Ohio association of realtors, which shall deposit the 432  
contributions into a property disaster relief fund maintained 433  
under the Ohio realtors charitable and education foundation. 434

The registrar shall pay the contributions the registrar 435  
receives pursuant to section 4503.752 of the Revised Code to 436  
buckeye corvettes, incorporated, which shall use the 437  
contributions to pay for its charitable activities and programs. 438

The registrar shall pay the contributions the registrar 439  
receives pursuant to section 4503.763 of the Revised Code to the 440  
Ohio history connection to be used solely to build, support, and 441  
maintain the Ohio battleflag collection within the Ohio history 442  
connection. 443

The registrar shall pay the contributions the registrar 444  
receives pursuant to section 4503.764 of the Revised Code to the 445

(d) A child, including those by adoption, or a stepchild;

(e) A grandchild, including those by adoption, or a step-grandchild;

(f) Any other lineal descendant not otherwise listed in 878  
division (D) (2) of this section; 879

(g) A grandparent or great-grandparent. 880

**Sec. 4503.436.** (A) Any person who has been awarded the 881  
Ohio national guard Ohio cross may apply to the registrar of 882  
motor vehicles for the registration of any passenger car, 883
