10. Whereas:	The United Nations states in its documents that "the equality and non-
11.	discrimination guarantee provided by international human rights law
12.	applies to all people, regardless of sex, sexual orientation and gender
13.	identity or 'other status.'"; and,
14. Whereas:	It is time for the State of Ohio to follow the lead of many progressive
15.	institutions before them and add non-discrimination laws that no person
16.	shall be discriminated by their sexual orientation or gender identity or
17.	expression; and,
18. Whereas:	Ohio legislative leaders have pushed for enactment of the bipartisan Ohio
