Chair Vitale, Vice Chair Kick, Ranking Member Denson, and Members of the House Energy and Natural Resources Committee, my name Patrick J. O'Connor, thank you for the opportunity to speak to you today as an opponent to Ohio Substitute House Bill 6.

Ohio needs a comprehensive Energy Policy. Substitute House Bill No. 6 is not the answer. Bi-Partisanship is how we can achieve it.

This bill pits Ohioans against Ohioans.

It pits small businesses against big businesses. Small manufacturers like Berea Manufacturing are disproportionately impacted while FirstEnergy Solutions, a bankrupt former FirstEnergy subsidiary, would get a bail out. This bill pits emerging energy producers against entrenched energy interests. For example, wind development has languished because of the onerous setback requirement. In fact, Ohio has lost a billion dollars worth of economic benefits because of the <u>restrictive turbine setback requirement</u>. As a result, wind developers have dropped plans for more than 3,300 MW of new wind power for the state. These projects would have powered close to a million homes and created 13,000 jobs as well as provided \$660 million dollars in tax payments to local schools and governments. Substitute House Bill No. 6 needs to include correcting the wind turbine setback requirement. This bill pits struggling Southern Ohio against prosperous Northern Ohio. The proposed legislation will provide relief to the school districts covered by the two nuclear power plants by helping to keep them whole while the Southern Ohio coal fired plants devaluation will accelerate the further erosion of the tax base of these school districts and forcing massive cuts.
