Re: Sub. H.B. 177 - Medical Care

Dear Chairman Lipps:

As President of the Academy of Medicine of Cleveland & Northern Ohio (AMCNO), an organization representing more than 5,000 physician, resident and medical student members in Northern Ohio, I am writing on behalf of the organization and our members to voice our opposition to Sub. H.B. 177 – a bill that would eliminate the requirement for advanced practice registered nurses (APRNs) to obtain collaboration agreements with supervising physicians in order to practice.

The AMCNO supports the use of patient-centered, team-based care. A team-based approach includes physicians and other healthcare professionals working together, sharing information and making decisions for the good of the patient. The key to better health outcomes as well as cost containment in the healthcare system is coordinated care provided by a team of healthcare professionals who work in collaboration.

Every member of the healthcare team plays a critical role. Nurses, therapists, pharmacists, and others each do their part in a team *led by a physician*. Physicians bring to the team the highest level of training and abilities and are the best qualified to guide the other members of the team. While we value the abilities and contributions of APRNs and all nurses, we do not believe they can take the place of a fully trained physician. The team approach is effective and efficient, and it ensures that the patient receives safe, coordinated care that minimizes fragmented or unnecessary treatment.

The AMCNO remains opposed to this legislation, and we ask that Ohio continue to utilize the physician-led, team-based approach to care as the safest and most efficient way to provide care to our citizens.
