I urge you to act to make voting safe and secure for Ohioans and NOT to support any bill that would make voting harder.

This bill is not in the interest of Ohio voters whom you represent as a member of this committee.

Vote NO on HB 680 and support common sense reforms to our election laws that make voting more accessible and efficient and that encourage voter participation. Rather than making it harder to vote, you should be working to make elections easier on Board of Elections officials and voters. **Make vote by mail easier, not harder.**

Send prepaid postage for ballot applications & ballots. The Secretary of State and Board of Elections officials support this action and mailing of applications is already funded.

Allow online absentee ballot requests which save money and time.

Add additional early voting sites and drop boxes, rather than having only 1 per county.
