UNIQUE LIFE EXPERIENCES

- Personal connection to the field of audiology and speech language pathology because of my own experience of living with a hearing loss. Born with a bilateral, sloping severe to profound loss, and was not identified until the age of 4. Mainstreamed in public school with accommodations. My personal life journey with a hearing loss has equipped me to be an audiologist who can provide empathy to patients and their families. I find that many of the children I work with have an immediate trust and connection with me when I show them my hearing aids. The parents also find "encouragement" in seeing a

successful adult who has a hearing loss when they are grieving the “loss” of their child’s hearing.
