**A BILL**

To enact sections 5534.407, 5534.60, 5534.601, 1  
5534.602, 5534.752, 5534.812, 5534.814, 2  
5534.818, 5534.822, 5345.823, 5534.824, 3  
5534.825, 5534.826, 5534.881, 5534.883, 4  
5534.884, 5534.89, 5534.896, 5534.898, 5534.91, 5  
and 5534.913 of the Revised Code to designate 6  
multiple memorial highways and bridges. 7

**BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:**

**Section 1.** That sections 5534.407, 5534.60, 5534.601, 8  
5534.602, 5534.752, 5534.812, 5534.814, 5534.818, 5534.822, 9  
5345.823, 5534.824, 5534.825, 5534.826, 5534.881, 5534.883, 10  
5534.884, 5534.89, 5534.896, 5534.898, 5534.91, and 5534.913 of 11  
the Revised Code be enacted to read as follows: 12

**Sec. 5534.407.** In addition to any other name prescribed by 13  
the Revised Code or otherwise, the eastbound and westbound lanes 14  
of state route number two between the intersection of that route 15  
and state route number three hundred six and the intersection of 16  
that route and state route number six hundred fifteen, in Lake 17  
county, shall be known as the "Patrolman Mathew Mazany Memorial 18

Highway." 19

The director of transportation may erect suitable markers 20  
along the highway indicating its name. 21

**Sec. 5534.60.** In addition to any other name prescribed in 22  
the Revised Code or otherwise, the northbound and southbound 23  
lanes of United States route number sixty-two between Staunton- 24  
Sugar Grove road and Greenfield Sabina road, in Fayette county, 25  
shall be known as the "PFC William Boggs, CPL Sam Boggs, and SGT 26  
Robert Boggs Memorial Highway." 27

The director of transportation may erect suitable markers 28  
along the highway indicating its name. 29

**Sec. 5534.601.** In addition to any other name prescribed in 30  
the Revised Code or otherwise, the northbound and southbound 31  
lanes of state route number one hundred eight between the 32  
southern border of Henry county and the northern border of Henry 33  
county shall be known as the "RDML Alene Duerk Memorial 34  
Highway." 35

The director of transportation may erect suitable markers 36  
along the highway indicating its name. 37

**Sec. 5534.602.** In addition to any other name prescribed in 38  
the Revised Code or otherwise, the northbound and southbound 39  
lanes of state route number sixty-six between Houston road and 40  
Roeth road, in Shelby county, shall be known as the "SFC Charles 41  
Gregory Huston Memorial Highway." 42

The director of transportation may erect suitable markers 43  
along the highway indicating its name. 44

**Sec. 5534.752.** The bridge spanning the Maumee river in 45  
Henry county and being a part of the highway known as state 46

route one hundred nine shall be known as the "Damascus Bridge." 47

The director of transportation may erect suitable markers 48  
upon the bridge or its approaches indicating its name. 49

**Sec. 5534.812.** In addition to any other name prescribed in 50  
the Revised Code or otherwise, the northbound and southbound 51  
lanes of interstate route number four hundred seventy-five 52  
between hill avenue and state route number two, in Lucas county 53  
only, shall be known as the "SGT Alex Drabik Memorial Highway." 54

The director of transportation may erect suitable markers 55  
along the highway indicating its name. 56

**Sec. 5534.814.** The bridge spanning Grand river that is a 57  
part of Fairport road and that is a primary entrance and exit to 58  
Fairport Harbor, in Lake county, shall be known as the "Col. 59  
Donald Blakeslee Memorial Bridge." 60

The director of transportation may erect suitable markers 61  
upon the bridge or its approaches indicating its name. 62

**Sec. 5534.818.** In addition to any other name prescribed in 63  
the Revised Code or otherwise, that portion of the road known as 64  
state route number one hundred fifty-two, running in a northerly 65  
and southerly direction between the intersection of that route 66  
with county road fifty-six and the intersection of that route 67  
with township road two hundred forty-nine, in Jefferson county 68  
only, shall be known as the "PFC George Dennis McClelland 69  
Memorial Highway." 70

The director of transportation may erect suitable markers 71  
along the highway indicating its name. 72

**Sec. 5534.822.** In addition to any other name prescribed by 73  
the Revised Code or otherwise, the northbound and southbound 74

lanes of interstate route number seventy-one between mile marker 75  
twenty-two and mile marker twenty-three in Warren county shall 76  
be known as the "Veterans Suicide Memorial Mile." 77

The director of transportation may erect suitable markers 78  
along the highway indicating its name. 79

**Sec. 5534.823.** In addition to any other name prescribed by 80  
the Revised Code or otherwise, the eastbound and westbound lanes 81  
of state route number one hundred twenty-five, between mile 82  
marker four and mile marker five, in Brown county only, shall be 83  
known as the "PFC M. Preston Wheeler Memorial Highway." 84

The director of transportation may erect suitable markers 85  
along the highway indicating its name. 86

**Sec. 5534.824.** In addition to any other name prescribed in 87  
the Revised Code or otherwise, the northbound and southbound 88  
lanes of state route number sixty-five between the intersection 89  
of that route and state route number sixty-four and the 90  
intersection of that route and the western border of Wood 91  
county, in Wood county only, shall be known as the "Master Chief 92  
Special Warfare Operator (SEAL) Edward C. Byers, Jr. Medal of 93  
Honor Recipient Highway." 94

The director of transportation may erect suitable markers 95  
along the highway indicating its name. 96

**Sec. 5534.825.** In addition to any other name prescribed in 97  
the Revised Code or otherwise, the northbound and southbound 98  
lanes of state route number twenty-five between the intersection 99  
of that route and United States route number twenty and the 100  
intersection of that route and United States route number 101  
twenty-three, in Wood county only, shall be known as the "SGT 102  
Arthur A. Mora, Jr. Memorial Highway." 103

The director of transportation may erect suitable markers 104  
along the highway indicating its name. 105

**Sec. 5534.826.** In addition to any other name prescribed in 106  
the Revised Code or otherwise, the eastbound and westbound lanes 107  
of United States route number thirty-six between the 108  
intersection of that route and the western border of Coshocton 109  
county and the intersection of that route and state route number 110  
seventy-nine, in Coshocton county only, shall be known as the 111  
"Charles C. Nichols Memorial Highway." 112

The director of transportation may erect suitable markers 113  
along the highway indicating its name. 114

**Sec. 5534.881.** In addition to any other name prescribed in 115  
the Revised Code or otherwise, the northbound and southbound 116  
lanes of state route number ninety-nine between the intersection 117  
of that route and county road number sixty-four and the 118  
intersection of that route and county road number one hundred 119  
nineteen, in Huron county, shall be known as the "Lance Corporal 120  
James Sprowl Memorial Highway." 121

The director of transportation may erect suitable markers 122  
along the highway indicating its name. 123

**Sec. 5534.883.** In addition to any other name prescribed in 124  
the Revised Code or otherwise, the northbound and southbound 125  
lanes of United States route number twenty-three between mile 126  
marker six and mile marker eight, within Ross county, shall be 127  
known as the "SGT Michael Keith Hamner Memorial Highway." 128

The director of transportation may erect suitable markers 129  
along the highway indicating its name. 130

**Sec. 5534.884.** In addition to any other name prescribed in 131  
the Revised Code or otherwise, the northbound and southbound 132

lanes of state route number sixty-five between county road H and 133  
state route number one hundred ten, in Henry county, shall be 134  
known as the "LTC Kevin Sonnenberg Memorial Highway." 135

The director of transportation may erect suitable markers 136  
along the highway indicating its name. 137

**Sec. 5534.89.** (A) In addition to any other name prescribed 138  
in the Revised Code or otherwise, the portion of the road known 139  
as state route number fifty-three, commencing at the 140  
intersection of that route and water street and proceeding in a 141  
southerly direction to the Catawba island township line in 142  
Ottawa county shall be known as the "Catawba Island Township 143  
Veterans Memorial Highway." 144

(B) The director of transportation may erect suitable 145  
markers along the highway indicating its name. 146

(C) Subject to approval by the director in relation to the 147  
marker size, color, format, and method of placement, the Catawba 148  
island township board of trustees may erect auxiliary markers in 149  
conjunction with the markers erected by the director under 150  
division (B) of this section, displaying the following names and 151  
any other name of a United States military veteran approved by 152  
the board: 153

(1) Private First Class William E. Galloway; 154

(2) SP4 James M. Davenport. 155

**Sec. 5534.896.** The bridge that is part of state route 156  
number six hundred three, located in the village of Plymouth in 157  
Huron and Richland counties, and being a part of the road known 158  
as Trux street, shall be known as the "Trucks Bridge." 159

The director of transportation may erect suitable markers 160

upon the bridge or its approaches indicating its name. 161

**Sec. 5534.898.** In addition to any other name prescribed by 162  
the Revised Code or otherwise, the northbound and southbound 163  
lanes of state route number four between the intersection of 164  
that route and Owens road west and the intersection of that 165  
route and Somerlot Hoffman road west, in Marion county only, 166  
shall be known as the "SGT David S. Harris Memorial Highway." 167

The director of transportation may erect suitable markers 168  
along the highway indicating its name. 169

**Sec. 5534.91.** In addition to any other name prescribed in 170  
the Revised Code or otherwise, the southbound lane of interstate 171  
route number seventy-one commencing at mile marker one hundred 172  
two and continuing to mile marker one hundred, in Franklin 173  
county, shall be known as the "James H. Hough Memorial Highway." 174

The director of transportation may erect suitable markers 175  
along the highway indicating its name. 176

**Sec. 5534.913.** In addition to any other name prescribed in 177  
the Revised Code or otherwise, the northbound and southbound 178  
lanes of interstate route number two hundred seventy-one between 179  
South Woodland road and Harvard road, in Cuyahoga county, shall 180  
be known as the "Ronald H. Barron Memorial Highway." 181

The director of transportation may erect suitable markers 182  
along the highway indicating its name. 183
