A BILL

To enact section 187.14 of the Revised Code to 1
create the Competitive Global Air Service 2
Development Grant Program and to make an 3
appropriation. 4

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

Section 1. That section 187.14 of the Revised Code be 5
enacted to read as follows: 6

Sec. 187.14. (A) JobsOhio shall establish the competitive 7
global air service development grant program. Under the program, 8
JobsOhio shall provide grants to air carriers to support the 9
establishment of new direct international and domestic air 10
service to and from Ohio airports. The grants shall provide 11
minimum revenue guarantees and marketing assistance to such air 12
carriers. In making grants under this section, JobsOhio shall 13
give priority to air carriers establishing new direct air 14
service between Ohio and destinations that are located in the 15
European Union or Japan. 16

(B) JobsOhio shall establish and administer all aspects of 17
the grant program, including eligibility requirements for 18
receiving a grant under the program. 19

(C) Not later than the last business day of January of 20
each year, JobsOhio shall prepare and submit a written report to 21
the general assembly detailing all aspects of the grant program 22
occurring during the immediately preceding calendar year. 23

Section 2. All items in this section are hereby 24
appropriated as designated out of any moneys in the state 25
treasury to the credit of the designated fund. For all 26
appropriations made in this act, those in the first column are 27
for fiscal year 2020 and those in the second column are for 28
fiscal year 2021. The appropriations made in this act are in 29
addition to any other appropriations made for the FY 2020-FY 30
2021 biennium. 31

The foregoing appropriation item 195XXX, Air Service 38
Development, shall be allocated to JobsOhio to operate the 39
competitive global air service development grant program as 40
described in section 187.14 of the Revised Code. 41

Section 3. Within the limits set forth in this act, the 42
Director of Budget and Management shall establish accounts 43
indicating the source and amount of funds for each appropriation 44
made in this act, and shall determine the form and manner in 45
which appropriation accounts shall be maintained. Expenditures 46
from appropriations contained in this act shall be accounted for 47

as though made in the main operating appropriations act of the	48
133rd General Assembly.	49
The appropriations made in this act are subject to all	50
provisions of the main operating appropriations act of the 133rd	51
General Assembly that are generally applicable to such	52
