BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

Section 1. That section 4503.53 of the Revised Code be	3
enacted to read as follows:	4
Sec. 4503.53. (A) The owner or lessee of any passenger_	5
car, noncommercial motor vehicle, recreational vehicle, or other	6
vehicle of a class approved by the registrar of motor vehicles	7
may apply to the registrar for the registration of the vehicle	8
and issuance of "Ohio Carpenters" license plates. The	9
application may be combined with a request for a special	10
reserved license plate under section 4503.40 or 4503.42 of the	11
Revised Code. Upon receipt of the completed application and	12
compliance by the applicant with divisions (B) and (C) of this	13
section, the registrar shall issue to the applicant the	14
appropriate vehicle registration and a set of "Ohio Carpenters"	15
license plates and a validation sticker, or a validation sticker	16
alone when required by section 4503.191 of the Revised Code.	17

In addition to the letters and numbers ordinarily

inscribed on the license plates, "Ohio Carpenters" license	19
plates shall display an appropriate logo and words that are	20
selected by representatives of the Ohio carpenters union and	21
approved by the registrar. "Ohio Carpenters" license plates	22
shall display county identification stickers that identify the	23
county of registration as required under section 4503.19 of the	24
Revised Code.	25
(B) "Ohio Carpenters" license plates and a validation	26
sticker, or validation sticker alone, shall be issued upon	27
receipt of an application for registration of a motor vehicle	28
under this section; payment of the regular license tax as	29
prescribed under section 4503.04 of the Revised Code, any	30
applicable motor vehicle license tax levied under Chapter 4504.	31
of the Revised Code, any applicable additional fee prescribed by	32
section 4503.40 or 4503.42 of the Revised Code, an additional	33
administrative fee of ten dollars; and compliance with all other	34
applicable laws relating to the registration of motor vehicles.	35
(C) The registrar shall deposit the administrative fee of	36
ten dollars, the purpose of which is to compensate the bureau of	37
motor vehicles for additional services required in the issuing	38
of "Ohio Carpenters" license plates, into the state treasury to	39
the credit of the public safety - highway purposes fund created	40
in section 4501.06 of the Revised Code.	41
