**A BILL**

To amend Section 237.30 of H.B. 529 of the 132nd 1  
General Assembly and Section 237.10 of H.B. 529 2  
of the 132 General Assembly, as subsequently 3  
amended, to make a capital appropriation for 4  
school facilities assistance. 5

**BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:**

**Section 1.** That Section 237.30 of H.B. 529 of the 132nd 6  
General Assembly be amended to read as follows: 7

**Sec. 237.30.** The Ohio Public Facilities Commission is 8  
hereby authorized to issue and sell, in accordance with Section 9  
2n of Article VIII, Ohio Constitution, and Chapter 151. and 10  
particularly sections 151.01 and 151.03 of the Revised Code, 11  
original obligations in an aggregate principal amount not to 12  
exceed ~~\$375,000,000~~\$475,000,000, in addition to the original 13  
issuance of obligations heretofore authorized by prior acts of 14  
the General Assembly. These authorized obligations shall be 15  
issued, subject to applicable constitutional and statutory 16  
limitations, as needed to provide sufficient moneys to the 17

credit of the School Building Program Assistance Fund (Fund 18  
7032) to pay the state share of the costs of constructing 19  
classroom facilities pursuant to Chapter 3318. of the Revised 20  
Code. 21

**Section 2.** That existing Section 237.30 of H.B. 529 of the 22  
132nd General Assembly is hereby repealed. 23

**Section 3.** That Section 237.10 of H.B. 529 of the 132nd 24  
General Assembly, as most recently amended by Am. Sub. S.B. 51 25  
of the 132 General Assembly, be amended to read as follows: 26
