

evaluated on Monday, March 26, 2012 and a decision will be made whether or not Ms. Grant should be admitted to the psych floor.

7. Prior to going to the hospital Ms. Grant left the three youngest children with Maternal Grandmother. Ms. Grant had been informed that maternal grandmother was not an appropriate caregiver due to her mental health. Ms. Grant discussed the need for maternal grandmother to have a guardian appointed due to her own mental health and that maternal grandmother was overly aggressive with the children. Child-1 was staying at the family home with an adult brother. The adult brother punched Child-1 and caused a severe nose bleed. Child-1 then went to stay with maternal great grandmother. A sibling to the children lives in maternal great grandmother's home. This sibling has sexual offending behaviors and is in treatment. This sibling was court ordered out of the family home and was not to have contact with minor children. Maternal *Grant* Grandmother has provided appropriate care for the sibling. The children have been staying with their big brother/big sister but this couple has stated they cannot care for the children on a long term basis.

8. Mr. Arnold has a significant criminal history including multiple charges of domestic violence, burglary and drug related charges. Mr. Arnold is currently incarcerated on drug trafficking and drug possession charges. His expected release date is March 2013.
9. The family has a history of severe domestic violence. Historically, Mr. Arnold has physically and sexually abused Ms. Grant in front of the children.

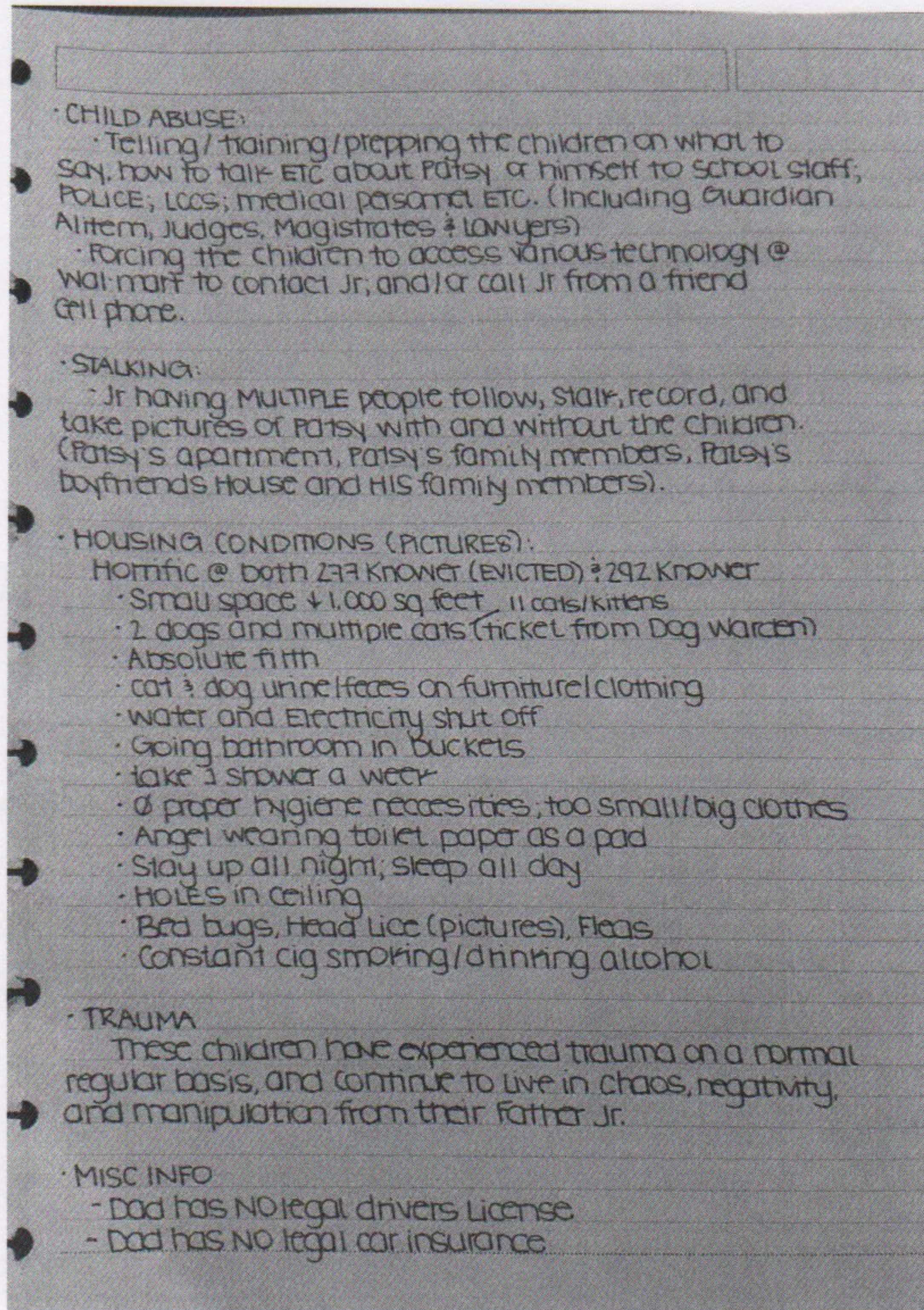

Your Honorable Judge Skow,

Our parents have always tried to teach us the difference between right and wrong. That we all have choices to make in life and when we do not make the right choices or do not stop to think about the outcome of our actions, we have to deal with the consequences.

For the past seven years Clarence has received a slap on the hand for his actions. Until now no one has taken the charges brought upon him seriously. He has been given several opportunities to straighten his life out. He was told to go to counseling and he was told to go to domestic violence classes to better help him to control his temper, but he has chosen not to. He FEELS he has to go to counseling because the Judges have made wrong decisions, not because he has done anything wrong. Clarence does not believe he has a problem, and that is where he needs to begin. He needs to start taking responsibilities for his own actions. To learn the differences between RIGHT and WRONG.

Any way that you look at it , abuse is abuse. To have someone constantly put you down in front of his friends, is abuse. To have someone push, slap, punch, or hit you, is abuse. To have someone threaten you, is abuse. To have someone neglect you, is abuse. To have someone force you to have sex with them when you say NO, is abuse. Whether you are talking to your husband, your boyfriend, a stranger, or to anyone, NO MEANS NO. There are many other forms of abuse, but these are the ones that either one of us, both of us, or our children have experienced from Clarence in the past.

In March of 1997, Clarence was put on probation by Judge Amy Berling. In his probation he was REQUIRED to go to counseling and to mandatory urine drops to test for alcohol and drugs. His probation was to last for two (2) years. He lasted approximately a month, and then he once again chose not to go. In between being put on probation and now he chose once again to make another wrong choice by being physically, emotionally, and sexually abusive again. In not following the requirements of his probation he is supposed to be incarcerated for six (6) months to run concurrent with any sentence you may or may not give him.

His emotional, physical, and sexual abuse has not only affected our lives but the lives of our families, our children, and our future to come. He has lied and manipulated us so many times in the past that it just has not affected us at that moment but the for the rest of our lives. We built our lives around someone we thought loved us. I thought he loved ONLY me, she thought he loved ONLY her. In doing this we became dependent on him and lost ourselves.

We became people who hung on his every promise, which we have now come to realize were broken promises. We lived in a world of lies and deceit. All five (5) of our children were conceived out those lies and deceit. Two (2) of these children being nine (9) months apart and two (2) being two (2) weeks apart.

His abuse has also had a strong impact on his children. Three of them being in counseling. To have a four (4) year old child look at you and say "my daddy hit my mommy", "my daddy has a gun", "my daddy said he was going to shoot my mommy" has gotten to be the worst outcome of this whole situation. Children need stability in their lives, but that is something his sons have never had because they have had to move on more than a few occasions due to Clarence's violent actions. His violent behavior has also been directed towards other people as well, such as his own mother. The case may have been dismissed but that does not denounce the fact that he has raised a hand to his own mother.

We were always told to follow through with whatever we believe in. By pursuing these charges we are trying to ensure the safety of not only other people but the lives of other children Clarence may have already fathered or will father in the future.

Your Honorable Judge Skow,

My name is Victoria Moreno. I came before you on May 28, 1998 in the case of Clarence Arnold, Jr., asking you to give Clarence the maximum time possible for threatening me in courtroom 4 at the municipal court building. I was not the only one who was threatened that day. Patsy Grant was also with me and she too was harassed by Clarence.

Clarence has had a very violent past. I have one charge of domestic violence against him. Patsy has too many to count. Judge Berling, at the municipal court building, had put Clarence on 2 years probation for my charge against him. He was to have mandatory counseling and to do urine drops every week for two years. He did not follow through with this.

It has come to my attention that Clarence has written to you in regards to an early release. On behalf of my children and I, I am asking you to please decline his request. You stated yourself that day in court that you had no doubt in your mind that Clarence would in fact try to hurt either Patsy or myself. I am very afraid that if he is released that he will try to harm either my children or me.

I have received many letters from Clarence. They have all gone in the garbage, unopened. I have not responded in anyway to him. I wish to have NO contact with Clarence at all. I am going to school full time and I am also working. I am trying to go on with my life. I know that he will not be incarcerated forever, but for the little time that he will be in, I feel somewhat safe.

Patsy and I read a victim impact statement to you on May 28, 1998. I have enclosed that statement and I ask that you read it over and come to a decision based on what you read. I also ask that you try to remember that when Patsy and I read that statement to you that Clarence showed no remorse for anything he has done.

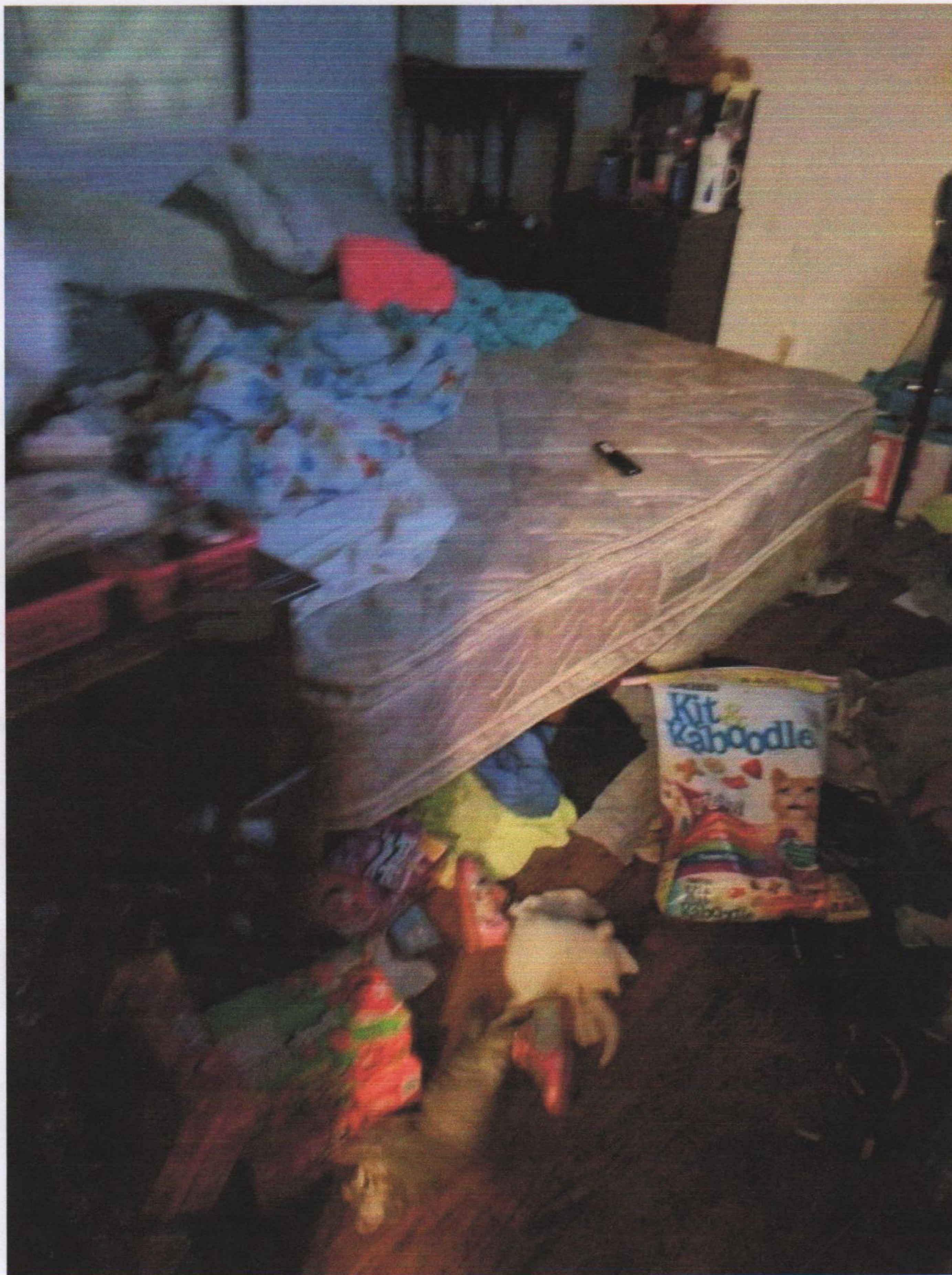

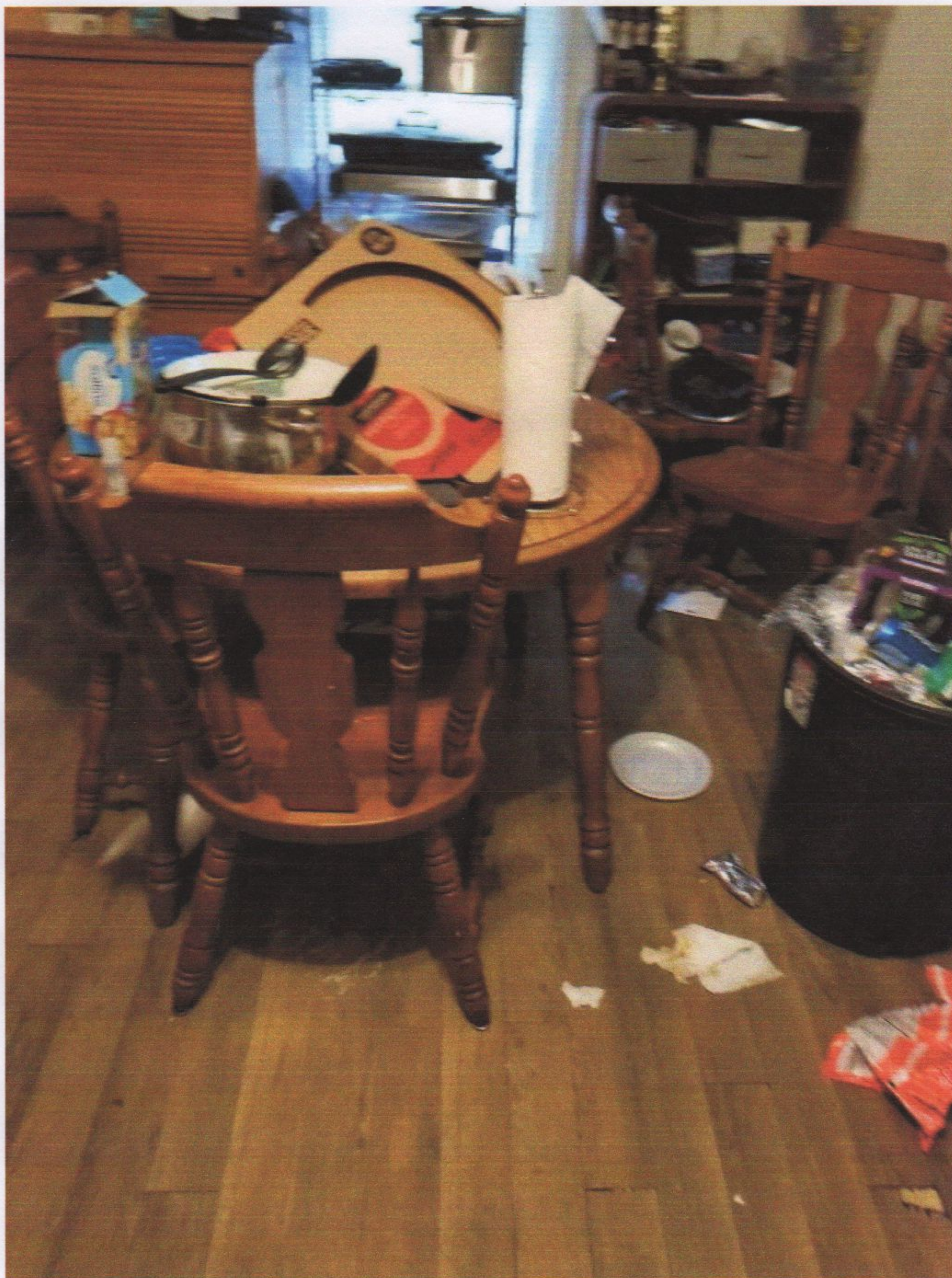
