Thank you for the opportunity to speak today regarding H.B. 435

The issue is simple, summarized by one question,
Do I as an American Citizen have dominion over my personal
Health care? I and many other Ohioans believe this is a fundamental human right.

I respect Rep Cupp, Senator Matt Huffman and the Governors position That they do not want to burden businesses with more regulation; but this is much broader than regulating business. It should not be lawful for a Business to make a vaccine a condition of employment. No Government, city, municipality, political subdivision should have the power to prevent entry to public buildings or deny services based upon vaccine status. Non-profit, health care facilities should not be permitted to make a vaccine a condition of employment or receipt of services based upon vaccine status. Universities, public or private schools at all levels should not have the standing to make a vaccine a condition to attend classes, or participate in daily life activities.

All these entities are by law prohibited to discriminate against employees. Mandating the covid vaccine or frequent covid testing discriminates against the employee who chooses not to get vaccinated. The vaccinated employee is equally capable of transmitting the virus yet is not required to submit to testing.

Should there be limitations on our medical freedom for the benefit of public health? I ask you how the covid vaccine serves the public health. Fauci and Walensky have both publically stated this vaccine does not prevent transmission or infection. The ability to become infected and the ability to transmit the virus is the same for vaccinated and unvaccinated.

The number of businesses and health care facilities mandating the covid vaccine increased substantially after Biden announced his plan to force vaccinate the population by placing punitive damages on businesses that do not co-operate. Businesses in Ohio may welcome legislative relief from this HR nightmare and interruption to their work force.

If the vaccine is so important I ask why is Congress and Senate, the Judicial branch and USPS are all exempt? Why are tens of thousands of illegal aliens

permitted across our boarders without a covid test or requirement to be vaccinated.

This version of the vaccine distributed in the USA is not FDA approved It is ineffective

Rep Ron Jonson presented on the House floor using data from England since the data in the USA is not transparent. Out of 600,000 cases of covid 27% were fully vaxxed, 23% were partially vaxxed, 43 % were unvaxxed

I have seen reports from Israel that stated 46% of their covid cases were fully vaccinated. Israel, Gibraltar, and Iceland are among the highest percentage of vaccinated populations in the world yet have the highest infection rates they have ever experienced.

This vaccine is dangerous

of the 2500 covid deaths in England , 63% were fully vaccinated, 28 % were unvaxxed

An article on vaccine impact.com quoted over a million serious injuries resulting from the vaccine in England, 22000 deaths in Brasil, 15,000 deaths in the EU. 6000 deaths have been reported in the USA but that number is likely understated based upon information from numerous whistle blowers relating how they were forbidden by their health care employers to report adverse reactions or deaths to VAERS

Ohioans need protection from a mandate requiring this vaccine.

The Federal Governments response to this information is censorship and doubling down on their efforts to coerce people to be vaccinated.

The mandate will not stop with the job requirement. Look at Canada, Australia, and Israel to learn how their people who choose medical freedom have been ostracized from society.

We are not asking for more exemption opportunities.

We are asking for laws to protect our basic human right of authority over our personal health care.

You have the opportunity to confirm and protect medical freedom in Ohio. I hope you don't waste it.
