Chair Manchester, Vice Chair Cutrona, Ranking Member Liston, and members of the Committee, I thank you for this opportunity to offer proponent testimony on Substitute House Bill 4 on behalf of the Children Services Transformation (CST) Advisory Council and as an Ohio Juvenile Court Judge.

I am Judge Anthony Capizzi, Administrative Judge at Montgomery County Juvenile Justice Court. Please accept my apology for not attending in person to present my position on this critical issue. I preside over a Juvenile Treatment Court each Thursday where I will see approximately 25 youth struggling with drugs and/or alcohol.

Governor Mike DeWine established, as you may be aware, the CST Advisory Council in November 2019 to improve outcomes for Ohio's children. The Advisory Council was a multi-disciplinary group of subject matter experts and individuals with lived experience in the foster care system, including foster youth and biological, kinship, foster, and adoptive families. The Advisory Council hosted 10 regional foster care forums throughout the state shortly after our formation, to better understand local challenges. The council heard from nearly 500 Ohioans on their experiences with Ohio's foster care system. The forums were followed by 14 Advisory Council meetings, held from January to October 2020, to review additional written testimony and develop recommendations. In November, 2021, we issued our final report with 37 recommendations for reforming Ohio's children services system.

One of the critical recommendations in response to all the testimony we heard is the creation of a state-level ombudsman to handle concerns for all youth and caregivers

connected to the children services and foster care system. The specific recommendation is to:

Institute a statewide children services ombudsman. Establish a state-level ombudsman to independently investigate and resolve complaints made by or on the behalf of children and families involved with children services. Ohio should have an independent outlet for individuals to voice their concerns with the foster care system.

Substitute House Bill 4 current language supports the Advisory Council's vision for a statewide children services ombudsman. The language incorporates the testimony the council heard regarding the need for a comprehensive office that manages complaints and investigations and serves as a separate, neutral office from the Office of Families and Children, public county children services agencies and private foster care agencies. As written in the sub house bill, this office will be able to serve all children involved in the system, not just those in custody or foster care. The advisory council supports a collaborative design approach in developing the office that includes involvement of foster youth, county agencies, private providers and parents and caregivers. This approach along with the leadership of the office will ensure foster youth are heard and prioritized impartially.

In addition, the sub house bill addresses the council's key priorities of the office including:

- Authority: The ombudsman will be appointed by the Governor, have access to necessary records while maintaining confidentiality, have defined roles and responsibilities and an established communication mechanism including a tollfree number.
- Accountability: The office is expected to identify system issues and advocate for change, provide an annual report to the Governor, Legislature and ODJFS, record and track data and trends, and commit to evaluation and adjustments to operations as needed over time.
- **Outreach**: The office will provide public outreach, education, training, and advocacy.

Thank you again for the opportunity to provide this testimony, for Sub HB 4. I also thank the sponsors, Representative Manchester and Representative Plummer, for incorporating this imperative recommendation into the bill. Although I am unavailable to testify in-person, I can follow-up on any questions you may have.
