## Testimony on HB 110 House Finance Committee

Chairman Oelslager, Vice Chair Plummer, Ranking Member Crawley, and Esteemed Committee Members,

**I want to thank you for giving me the opportunity to testify before you today.**

**My name is Mindy Niehaus and I am the Social Services Coordinator of Independence of Portage County, and we are located in Portage County. We are a non-profit that provides supports for 95 Ohioans with intellectual and developmental disabilities and we employ 185.**

**I am very supportive of the budget initiatives outlined by Governor DeWine, Director Davis for the Department of Developmental Disabilities (DODD), and Director Miller for Opportunities for Ohioans with Disabilities (OOD). With these budget initiatives and the leadership of Director Davis (and Director Miller), Ohioans with developmental and intellectual disabilities will continue to receive the vital services that organizations like mine provide.**

We offer a multitude of opportunities to individuals from residential to employment services. We began serving youth a few years ago and this has proved to be a challenging yet rewarding experience. Youth with developmental disabilities have few residential options in Northeast Ohio. Our goal is to continue to grow the youth services we provide. In order to continue to successfully provide this service our staff would benefit from training that focuses specifically on youth with developmental disabilities. Additional funding would allow our fantastic staff to receive additional trainings as well as an increase in their wages. Staff really go above and beyond supporting individuals and deserve anything we can offer that increases their ability to provide the best services possible.

**To best support these services and the Ohioans who receive and provide them, I encourage you to add the following initiatives into Ohio's biennium budget:**

- Increase general revenue fund appropriations in DODD's budget to fund much needed Homemaker and Personal Care, Day and Vocational Services and Nonmedical Transportation Medicaid home and community-based waiver services rate increase.

*These increases will provide much needed funds for Direct Support Professional (DSP) wages, support for other front-line professionals and sustain the infrastructure necessary to provide our services.*

- Increase general revenue fund appropriations in DODD's budget to support the reimbursement formula for intermediate care facilities (ICF).
- Support a budget amendment that would allow ICFs to choose between a reimbursement rate freeze or a continuation of the formula for the first year of the biennium.
- Support the creation of a Task Force to address our system's workforce challenges. *This Task Force will identify several initiatives and projects designed to help providers recruit and retain a qualified workforce.*
- Support the as introduced budget for Opportunities for Ohioans with Disabilities
