Testimony - Members of the house, Rep LIsps, Committee members.

My name is Paige Stemen,

I've been in nursing for going on 20+ years. I come before you today, to testify in support of HB248. I've come to this stakehouse many times to voice our concerns on many issues, such as 2nd amendment, religious freedom, unconstitutional mandates, being issued by a complete, out of control administration. I've fought so hard, for so many years with some victories & some losses. Never in my entire life, would I've ever thought that'd I be having to come before a committee to beg a plea for a constitutional protected right to decide or decline a medication/vaccine, as to whether or not I'll be able to say NO to my or any employer that wants to mandate that we must vaccinate or be fired. I'm speaking on behalf of many, thousands of nurses who're protesting this ridiculous mandate, that is not law.

I've worked through many flu seasons, some worse than Covid. Never before have we had to mask & wear goggles, we all lived.
