Chair Wiggam, Vice Chair John, Ranking Member Kelly, and members of the State and Local Government Committee;

At the Regular Board Meeting on June 24, 2021, the Board approved the following statement and directed me to provide the statement to members of the State and Local Government Committee regarding opposition to HB 322 and HB 327:

As members of the Athens City Schools Board we strongly oppose HB 322 and HB 327. This regulation of and intrusion into curriculum, instruction, and training impedes free thought and free speech. These bills support a false or diluted understanding of our history. We ask that our state legislators carefully reconsider this unprecedented interference in public school curriculum.

Neither race, racism, gender, sexism, and other concepts outlined in these bills are "divisive". They are realities deserving of dialogue and understanding unimpeded by Ohio legislative intrusion. Students can have age-appropriate conversations about difficult issues and walk away with a broader understanding of their communities, state, nation, and world. This cannot happen when discussions about race, sex, and gender are not permitted. These bills will impede civil discourse and further the national divide.

These topics require thoughtful approaches supported by instruction and training. HB 327 strives to deny institutions the ability to provide training on issues and topics that the state government seeks to declare as "divisive". These topics however, are the realities that our students face every day. As with many other challenges experienced by our students, these require similar training and support for our teachers and staff as they work to support the needs of every student in Ohio.

HB 322 and HB 327 amount to government censorship of public education. As a school board we strongly reject this. We know this to be true; egregious governmental overreaches as outlined in HB 322 and HB 327 will be detrimental to the well-being of our students and to the dialogues so sorely needed.
