## RE: H.B. 423 Designating the All-American Soap Box Derby as the official state Gravity Racing Program

Honorable State Representatives:

My name is Mark Gerberich, President & CEO, for the International Soap Box Derby, Inc., an Akron, Ohio-based nonprofit organization that administers the All-American Soap Box Derby®, a youth gravity racing program which has run nationally since 1934.

I am writing this letter to strongly support House Bill 423 which would designate the All-American Soap Box Derby as the official gravity racing program for the State of Ohio. Being designated as Ohio's gravity racing program would be such an honor for our program, that for more than eighty years, has impacted the lives, not only of Ohio youth, but also the lives of more than a million youth worldwide.
